**RELEASE OF SECURITY INTEREST**

This RELEASE OF SECURITY INTEREST is dated and effective as of February 10, 2011, and is made by and between ETV Capital S.A., a corporation organized under the laws of Luxembourg, with a principal place of business at 6 rue Philippe II, L-2340, Luxembourg ("Secured Party") and Bullguard Limited, a corporation organized under the laws of the United Kingdom with a principal place of business at Capital Place, 120 Bath Road, Heathrow, Hounslow, UB3 5AN, United Kingdom ("Grantor").

**WITNESSETH:**

WHEREAS, on or about March 13, 2008, Grantor granted to Secured Party a lien on and security interest in the following trademarks registered with the U.S. Patent and Trademark Office: BULLGUARD (Reg. No. 3,004,358, issued October 4, 2005) and BULLGUARD and Design (Reg. No. 3,004,357, issued October 4, 2005) (the "Trademarks"); and
