## NOTICE OF SECURITY INTEREST IN U.S. TRADEMARKS

This Notice of Security Interest in U.S. Trademarks (this "**Notice of Security Interest**"), dated May 2, 2011, is made by TeleTracking Technologies, Inc., a Delaware corporation ("**TeleTracking**") and RadarFind Corporation, a Delaware corporation ("**Radar**") (TeleTracking and Radar are each individually a "**Grantor**" and collectively, the "**Grantors**") in favor of The Huntington National Bank (the "**Lender**").

WHEREAS, the Grantors have adopted, used and are using the United States trademarks listed on the annexed Schedule A, which trademarks are registered in or subject to trademark applications filed in the United States Patent and Trademark Office (the "**Trademarks**");

WHEREAS, pursuant to that certain First Amended and Restated Credit Agreement, dated of even date herewith, by and among TeleTracking, the other Borrowers (as defined therein) party thereto, Radar, the other Guarantors (as defined therein) party thereto and the Lender (as the same may be amended, restated, modified or supplemented from time to time, the "**Credit Agreement**"), the Grantors are obligated to the Lender and the Grantors have entered into that certain Patent, Trademark and Copyright Security Agreement, dated of even date herewith (the "**Trademark Grant**") in favor of the Lender; and

WHEREAS, pursuant to the Trademark Grant, the Grantors have mortgaged, pledged, granted and conveyed to the Lender, a first-priority security interest in and to and Lien on all of such Grantor's right, title and interest in and to the Trademarks, together with the goodwill associated therewith, and all proceeds thereof, including, without limitation, any royalties, claims for infringement and proceeds of sale or other disposition thereof (the "**Trademark Collateral**") to secure the payment and performance of the Obligations (as defined in the Credit Agreement).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, each Grantor does hereby confirm its grant to the Lender of a pledge of, security interest in, and Lien on, the Trademark Collateral to secure prompt payment and performance of the Obligations.

Each Grantor does hereby further acknowledge and affirm that the rights and remedies of the Lender with respect to the pledge of, security interest in, and Lien on, the Trademark Collateral made and granted hereby are more fully set forth in the Trademark Grant, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth in this Notice of Security Interest.

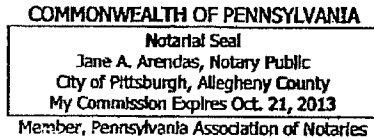



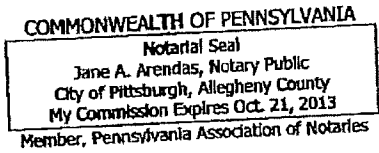
