PARTIAL RELEASE OF SECURITY INTEREST

This Partial Release of Security Interest (this "Partial Release") is by THE BANK OF NEW YORK MELLON TRUST COMPANY, N.A., not in its individual capacity but solely as Collateral Trustee (the "Collateral Trustee"), under that certain Fourth Lien Security Agreement, dated as of February 3, 2009 (as amended, supplemented and otherwise modified, the "Security Agreement"), between the Collateral Trustee and Hostess Brands, Inc. (formerly known as Interstate Bakeries Corporation) and each other Grantor a party thereto. This Partial Release is executed upon the express condition that nothing herein contained shall be construed to release the Collateral Trustee's security interest in, or impair the lien the Collateral Trustee has over any of the Collateral, except the Released Assets.
