**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARK RIGHTS**

This Release of Security Interest in Trademarks (this "Trademark Release"), dated as of May 16, 2011, is made by DEUTSCHE BANK TRUST COMPANY AMERICAS, as Collateral Agent for the Secured Lenders (the "Agent"), in favor of Enterprise Computer Systems, Inc., Activant Solutions Inc., Prophet 21, Inc., Prelude Systems, Inc. and Activant Wholesale Distribution Solutions Inc. (each a "Grantor," and collectively the "Grantors"). All capitalized terms used, but not otherwise defined herein, shall have the meanings ascribed to them in the Security Agreements (as defined below).

WHEREAS, pursuant to that certain Security Agreement, dated as of May 2, 2006, by and among Lone Star Merger Corp., Lone Star Holding Corp., certain subsidiaries of Lone Star Holding Corp. the Agent, and the Grantors and that certain Intellectual Property Security Agreement, dated as of January 7, 2009, by and among Activant Wholesale Distribution Solutions Inc., the other assignors from time to time party thereto and the Agent (each a "Security Agreement," and collectively the "Security Agreements"), the Grantors granted a security interest to the Agent in certain Trademarks, listed on Schedule A ("Secured Trademarks");

WHEREAS, pursuant to the terms and conditions set forth in the Security Agreements, the Agent and the Grantors entered into those certain Grants of Security Interest in United States Trademarks, dated as of May 2, 2006, November 14, 2008, January 7, 2009 and September 18, 2009 (as may be amended, modified, supplemented, extended, renewed, restated or replaced, the "Trademark Security Agreements"), for filing and recordal of the security interest granted under the Security Agreements with respect to the Trademarks;

WHEREAS, pursuant to the Trademark Security Agreements, Grantors granted to the Agent, a security interest in and continuing lien on all of Grantors' right, title and interest in, to and under the Secured Trademarks, subject to the terms and conditions of the Security Agreements;

WHEREAS, the Trademark Security Agreements were duly filed and recorded with the United States Patent and Trademark Office on May 23, 2006, at Reel and Frame numbers 3314/0750, 3314/0672, 3314/0872 and 3315/0001; on December 1, 2008, at Reel and Frame numbers 3896/0001 and 3895/0981; on January 13, 2009, at Reel and Frame number 3917/0768; and on September 21, 2009 at Reel and Frame number 4064/0861; and

WHEREAS, the Agent wishes to release, discharge, relinquish, terminate and dissolve its security interest in and continuing lien on all of Grantor's right, title and interest in, to and under the Trademarks, including without limitation the Secured Trademarks;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent agrees as follows:

1. The Agent hereby irrevocably releases, discharges, relinquishes, terminates and dissolves its security interest in and continuing lien on all of Grantor's right, title and interest in, to and under the Trademarks, including without limitation the Secured Trademarks, and reassigns and transfers any right, title and interest that the Agent may have in the Trademarks, including without limitation the Secured Trademarks to Grantor.

2. The Agent hereby authorizes Grantor or Grantor's authorized representative to (i) record this Trademark Release with the United States Patent and Trademark Office, and/or (ii) otherwise record or file this Trademark Release in the applicable governmental office or agency. The Agent further agrees to execute and deliver to Grantor any and all further documents and instruments, and do any and all further acts which Grantor (or its agents or designees) reasonably request (at Grantor's sole cost and expense) in order to confirm this Trademark Release and Grantor's right, title, and interest in, to or under the Trademarks, including without limitation the Secured Trademarks.

3. This Trademark Release shall be binding upon the Agent's successors and assigns.

4. THIS TRADEMARK RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK, INCLUDING, WITHOUT LIMITATION, SECTIONS 5-1401 AND 5-1402 OF THE NEW YORK GENERAL OBLIGATIONS LAW AND RULE 327(b) OF THE NEW YORK CIVIL PRACTICE LAW AND RULES.
