RELEASE

This Release (this “**Release**”) is made and entered into as of May 18, 2011 by JPMorgan Chase Bank, N.A., as Collateral Agent for the benefit of the Secured Parties (the “**Collateral Agent**”).

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of March 25, 2008 (the “**Security Agreement**”), PropertyBridge, Inc. (“**PBI**”) granted to the Collateral Agent for the benefit of the Secured Parties a security interest in all of PBI’s right, title and interest in and to certain trademarks, including, without limitation, the trademarks listed on Schedule A attached hereto (the “**Trademarks**”); and

WHEREAS, the Security Agreement has terminated.

WHEREAS, capitalized terms used but not defined herein are used in the manner provided in the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged the Collateral Agent hereby agrees as follows:


1. Release. The Collateral Agent hereby terminates and releases all mortgages, liens, and security interests granted to the Collateral Agent for the benefit of the Secured Parties in the Trademarks, together with all goodwill associated therewith and symbolized thereby, and all products and proceeds of the foregoing, including, without limitation, any claim by the Collateral Agent against third parties for past, present or future infringement or dilution of any Trademark or past, present or future injury to the goodwill associated with any Trademark.

2. Further Assurances. The Collateral Agent hereby authorizes the recordation of this Release with the United States Patent and Trademark Office and any other applicable state or national trademark office necessary to effect the terms of this Release and grants the attorney of record the power to insert on this Release any further identification that may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office, or the rules of other applicable state or national trademark offices, for recordation of this Release.
