TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of May 18, 2011, by GE CANADA FINANCE HOLDING COMPANY ("Secured Party"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, MADDOCKS SYSTEMS INC., a Canadian corporation ("Grantor"), and Merrill Lynch Capital Canada, Inc. ("Merrill Lynch") were parties to that certain Trademark Security Agreement dated as of September 5, 2006 (as amended, restated the "Security Agreement"), pursuant to which Grantor granted a security interest to Merrill Lynch in certain trademarks ("Trademarks") and Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Merrill Lynch, including the Trademarks set forth on Schedule 1 hereto;

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on September 6, 2006, at Reel 3386, Frame 0184;

WHEREAS, Merrill Lynch assigned its security interest in the Trademarks and Trademark Collateral to Secured Party pursuant to that certain Assignment of Security Agreement recorded by the Trademark Division of the United States Patent and Trademark Office on July 25, 2008 at Reel 3822, Frame 0566;

WHEREAS, Grantor has requested that Secured Party release its security interest in the Trademarks and Trademark Collateral and reassign any and all rights in the same to the Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Secured Party hereby releases its security interest in all of Grantor's right, title and interest in and to the following (collectively the "Trademark Collateral"):

(i) each Trademark listed on Schedule 1 annexed hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(ii) all products and proceeds of the foregoing, including without limitation, any claim by Grantor against third parties for past, present or future (a) infringement or dilution of any Trademark, or (b) injury to the goodwill associated with any Trademark.

2. Secured Party hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Secured Party, any and all of Secured Party's right, title and interest in and to the Trademarks and the Trademark Collateral.
