TRADEMARK ASSIGNMENT AGREEMENT

WHEREAS, Arlon LLC, a limited liability company organized and existing under the laws of the State of Delaware, located and doing business at 2811 S. Harbor Blvd., Santa Ana, CA 92704, U.S.A. WHEREAS, Assignor and Assignee are parties to the APA, pursuant to which Assignor has agreed to sell, and/or cause its applicable affiliates to sell, to Assignee, and Assignee has agreed to purchase from Assignor, certain purchased assets, including, without limitation, the Marks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns and transfers to Assignee, its successors and assigns, absolutely and forever, the entire and exclusive right, title and interest, whether statutory or at common law, in and to the Marks together with the right to sue and recover for all past, present or future causes of action for infringement, dilution of or damage or injury to the Marks, and the right to receive and retain the proceeds, profits or damages relating to such causes of action. Assignor further agrees, and to cause its affiliates and their respective employees, consultants, legal representatives, and its and their successors and/or assigns, to execute and have executed all documents, instruments and papers and to perform all acts, without any further consideration but at the cost and expense of Assignee, as deemed reasonably necessary by Assignee to perfect in Assignee the foregoing rights, title and interests, including the execution of any related domestic or foreign application documents. Assignor hereby authorizes and requests the Director of the United States Patent and Trademark Office to issue all registrations resulting from all the applications in the Marks to Assignee, its successors and assigns.

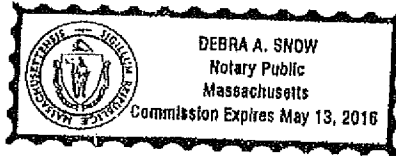
