## RELEASE OF SECURITY INTERESTS IN TRADEMARKS

The undersigned, SDA, Inc. (formerly known as Autobacs Strauss Inc.), a Delaware corporation (hereinafter, "SDA"), pursuant to the authority granted to SDA by the United States Bankruptcy Court for the District of Delaware in In Re: Autobacs Strauss Inc., Chapter 11 Case No. 09-10358 (CSS) (the "**Bankruptcy Case**") in the Findings of Fact, Conclusions of Law, and Order Confirming the Fourth Amended Joint Plan of Reorganization Proposed by Autobacs Strauss Inc. and the Official Committee of Unsecured Creditors dated September 15, 2010 (the "**Confirmation Order**"), hereby states that (i) pursuant to Paragraph 13 of the Confirmation Order, all assets of the debtor in the Bankruptcy Case vested in SDA free and clear of all liens, claims and interests, (ii) pursuant to Paragraph 28 of the Confirmation Order, the Confirmation Order constitutes all approvals and consents required to implement the aforementioned Plan of Reorganization, and (iii) SDA is executing this document to release and discharge the security interests set forth below:

1. Trademark Security Agreement dated August 6, 1992, by and between Chase Manhattan Bank (National Association), As Administrative Agent, with a principal place of business at 1155 Avenue of the Americas, New York, NY 10036-2711, WSR Corporation, a Minnesota corporation, The Whitlock Corporation, a Minnesota corporation and R&S/Strauss, Inc., a Delaware corporation, which Trademark Security Agreement was filed with the United States Patent and Trademark Office on August 6, 1992, and recorded in Reel 0888, Frame 0449, et seq., of the Trademark Assignment Records.

2. Amended Trademark Security Agreement dated August 6, 1992, by and between Chase Manhattan Bank (National Bank), As Administrative Agent, with a principal place of business at 1155 Avenue of the Americas, New York, NY 10036-2711 and Bank of America National Trust and Savings Association, which Trademark Security Agreement was filed with the United States Patent and Trademark Office on August 6, 1992, and recorded in Reel 0903, Frame 0124, et seq., of the Trademark Assignment Records.

Trademark Security Agreement dated May 27, 2005, by and between GMAC Commercial Finance LLC, a Delaware limited liability corporation, with a principal place of business at 1290 Avenue of the Americas, New York, NY 10104, and R & S Parts and Service, Inc., a Delaware corporation, which Trademark Security Agreement was filed with the United States Patent and Trademark Office on February 15, 2006, and recorded in Reel 3305, Frame 0309, et seq., of the Trademark Assignment Records.

6. Trademark Security Agreement dated August 11, 2006, by and between KIMCO Securities Corporation, a Delaware corporation, with a principal place of business at 3333 New Hyde Park Road, New Hyde Park, NY 11042, and R&S Parts & Service, Inc., a Delaware corporation, which Trademark Security Agreement was filed with the United States Patent and Trademark Office on August 17, 2006, and recorded in Reel 3371, Frame 0390, et seq., of the Trademark Assignment Records.

7. Trademark Security Agreement dated June 1, 1995, by and between National Canada Finance Corporation, a Delaware corporation, with a principal place of business at 125 West 55<sup>th</sup> Street, New York, NY 10019, WSR Corporation, a Delaware corporation, R&S/Strauss, Inc., a Delaware corporation, National Auto Stores Corp., a New York corporation and National Automotive Stores, Inc., an Ohio corporation, which Trademark Security Agreement was filed with the United States Patent and Trademark Office on June 12, 1995, and recorded in Reel 1364, Frame 0422, et seq., of the Trademark Assignment Records.

8. Trademark Security Agreement made as of June 13, 1990, by and between Security Pacific National Bank, with a principal place of business at 40 East 52<sup>nd</sup> Street, New York, NY 10022, WSR Acquisition Corporation, a Delaware corporation, The Whitlock Corporation, a Minnesota corporation, and R&S/Strauss, Inc., a Delaware corporation, which Trademark Security Agreement was filed with the United States Patent and Trademark Office on November 1, 1990, and recorded in Reel 0762, Frame 0094, et seq., of the Trademark Assignment Records.

9. Trademark Security Agreement made as of June 12, 1990, by and between Security Pacific National Bank, As Collateral Holder, with a principal place of business at 40 East 52<sup>nd</sup> Street, New York, NY 10022, WSR Acquisition Corporation, a Delaware corporation, The Whitlock Corporation, a Minnesota corporation, R&S/Strauss, Inc., a Delaware corporation, Rose Auto Stores -- Florida, Inc., Goodall-Enterprises, Inc., Whitlock Industries Corporation, National Automotive Stores, Inc., and National Auto Stores Corp., which Trademark Security Agreement was filed with the United States Patent and Trademark Office on June 13, 1990, and recorded in Reel 0746, Frame 0428, et seq., of the Trademark Assignment Records.

Upon the recording hereof, all right, title and interest of any secured party in and to the trademarks indicated in the above-referenced Trademark Security Agreements shall be released and discharged, including any security interest or conditional assignment created and existing thereunder on the property described in and covered thereby, and any secured party identified in the above-referenced Trademark Security Agreements shall, without any further action, be deemed to have reassigned to the undersigned any right, title and interest of the secured party in and to the "collateral" described therein, including the right to recover for past infringement of

any of the collateral and the goodwill of the business in connection with which the collateral is used and which is symbolized by any of the collateral.
