**TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

THIS TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Release"), is dated as of May 20, 2011, and made by THE BANK OF NEW YORK MELLON TRUST COMPANY, N.A. (formerly known as The Bank of New York Trust Company, N.A.) as Collateral Agent, ("Grantee") to Molecular Insight Pharmaceuticals, Inc. ("Grantor").

WHEREAS, pursuant to that certain Pledge and Security Agreement, dated as of November 16, 2007, made by Grantor in favor of Grantee (the "Security Agreement"), a security interest was granted by the Grantor to Grantee in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on November 16, 2007, at Reel 003663 and Frame 0884; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;


NOW, THEREFORE, for good and valuable consideration, Grantee agrees as follows:

1. Definitions. The term "Trademarks," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto.
2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademarks and reassigns, without recourse, representation or warranty, to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademarks.
3. Further Assurances. Grantee shall, at Grantor's expense, take all further actions, and provide to Grantor, Grantor's successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments in form and substance satisfactory to Grantee), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
