## TRADEMARK SECURITY AGREEMENT RELEASE

May 24 2011

**WHEREAS**, pursuant to that certain Trademark Security Agreement, dated as of November 7, 2006 (the "Trademark Security Agreement"), Chuy's Opco, Inc. ("Opco") and each of Opco's Subsidiaries identified on the signature pages thereof (collectively with Opco, the "Grantors") granted to Wells Fargo Capital Finance, Inc., a California corporation formerly known as Wells Fargo Foothill, Inc. (the "Secured Party"), a security interest in the trademarks listed on Schedule I attached hereto (the "Collateral").

**WHEREAS**, pursuant to the Payoff Letter, dated as of May 24, 2011, among the Grantors and the Secured Party (the "Payoff Letter"), the Secured Party agreed to release its liens in the Collateral, on and subject to the terms and conditions set forth therein.

**NOW THEREFORE**, the parties hereby agree as follow:


(A) Pursuant to the terms of the Payoff Letter, the Secured Party hereby confirms that upon receipt by the Secured Party of the Payout Amount (as defined in the Payoff Letter), all of its security interests and liens on the Collateral are terminated and released.

(B) The Secured Party hereby agrees that the Grantors and GCI Capital Markets LLC and its counsel are authorized to record copies of this release on behalf of the Secured Party with the United States Patent and Trademark Office.

(C) The Secured Party shall, at the Grantors' sole cost and expense, execute and deliver to or for the Grantors such additional documents and shall provide such additional information as the Grantors may reasonably require to carry out the terms of this release and the Payoff Letter.
