PARTIAL INTELLECTUAL PROPERTY SECURITY RELEASE AGREEMENT

WHEREAS, Alliant Techsystems Inc., a Delaware corporation, has entered into a Second Amended and Restated Credit Agreement dated as of October 7, 2010 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), with Bank of America, N.A., as Administrative Agent, and the other Agents and the Arrangers party thereto.

WHEREAS, as a condition precedent to the making of Loans by the Lenders and the issuance of Letters of Credit by the L/C Issuers under the Credit Agreement and the entry into Secured Hedge Agreements by the Hedge Banks from time to time, the Grantor has executed and delivered that certain Second Amended and Restated Security Agreement dated October 7, 2010 made by the Grantor and the other grantors party thereto to the Administrative Agent (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement").

WHEREAS, under the terms of the Security Agreement, the Grantor has granted to the Administrative Agent, for the ratable benefit of the Secured Parties, a security interest in, among other property, certain intellectual property of the Grantor, and has executed that certain Intellectual Property Security Agreement dated October 7, 2010, made by the Administrative Agent, the Grantor and the other grantors party thereto (the "IP Security Agreement"), for recording with the United States Patent and Trademark Office and other governmental authorities.

WHEREAS, the IP Security Agreement was recorded with the Patent Division of the United States Patent and Trademark Office on November 4, 2010 at Reel 025321 and Frame 0291 with respect to United States patents and patent applications;

WHEREAS, the IP Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on November 4, 2010 at Reel 04408 and Frame 0704 with respect to United States trademark registrations and applications; and

WHEREAS, at the request of Grantor and in accordance with the provisions of the Credit Agreement and the IP Security Agreement, the Collateral Agent now desires to release its security interest in and to the Grantors' right, title and interest in and to the Collateral identified in Schedule A to this IP Security Release (the "Released Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent agrees as follows:

SECTION 1. <u>Release of Security Interest</u>. The Collateral Agent hereby terminates and releases in its entirety its security interest in and to the Grantor's right, title and interest in and to the Released Collateral.

SECTION 2. <u>Recordation</u>. The Collateral Agent authorizes and requests that the United States Commissioner for Patents, the United States Commissioner for Trademarks and any other applicable government officer record this IP Security Release.

SECTION 3. Governing Law. This IP Security Release shall be governed by, and construed in accordance with, the laws of the State of New York.
