

GECC consents and agrees to execute and deliver, at the request and cost of Company, such further instruments, documents and release forms as Company may reasonably request to more effectively, release, terminate and extinguish any such liens and security interests upon such trademarks and service marks.

This Release shall be binding upon GECC's legal representatives, assigns and successors.
