TRADEMARK RELEASE

THIS TRADEMARK RELEASE is made as of July 6, 2011, by Canadian Imperial Bank of Commerce, as collateral agent (in such capacity, "**Grantee**").

W I T N E S S E T H:

WHEREAS, Grantee and Survey Sampling International, LLC, a Delaware limited liability company ("**Grantor**"), are parties to that certain Security Interest dated as of May 6, 2005 (the "**Security Agreement**"; capitalized terms used herein but not otherwise defined herein shall have the respective meanings ascribed to such terms in the Security Agreement), pursuant to which Grantor granted a security interest in and lien on all of Grantor's right, title and interest in and to the Trademarks, including the Trademarks listed on Schedule I hereto, together with the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action existing by reason of infringement thereof (collectively, the "**Trademark Collateral**"), as security for certain obligations owing by Grantor to Grantee;

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on May 27, 2005 at Reel 3093, Frame 0601; and


WHEREAS, Grantor has paid all of its outstanding indebtedness to the Grantee.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby terminates the Security Agreement and terminates, cancels and releases its security interest in all of Grantor's right, title and interest in and to the Trademark Collateral.
2. Grantee hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Grantee, any right, title and interest Grantee may have in and to the Trademark Collateral.
3. Grantee shall, at Grantor's expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Trademark Release.
