All capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed to those terms in the Credit Agreement and the Security Agreements (as defined below).

WHEREAS, the Grantors and the Royal Bank of Canada, as the Administrative Agent and the Collateral Agent, entered into that certain Credit Agreement dated as of December 9, 2009, as amended and restated on November 24, 2010 (as amended, restated, supplemented or otherwise modified from time to time, the "**Credit Agreement**");

WHEREAS, pursuant to the Credit Agreement, each Grantor executed and delivered that certain Security Agreement dated as of December 9, 2009 ("**2009 Security Agreement**"), pursuant to which the Grantors granted to the Collateral Agent, for the ratable benefit of the Secured Parties (as defined therein), a security interest in, among other property, certain Trademarks of the Grantors (the "**2009 Trademark Collateral**");

WHEREAS, the Grantors and the Collateral Agent entered into a new Amended and Restated Security Agreement dated as of November 24, 2010 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "**2010 Security Agreement**"; together with the 2009 Security Agreement, the "**Security Agreements**"), pursuant to which the Grantors granted to the Collateral Agent, for the ratable benefit of the Secured Parties (as defined therein), a security interest in, among other property, certain Trademarks of the Grantors (the "**2010 Trademark Collateral**"; together with the 2009 Trademark Collateral and any Trademarks pledged under the 2009 Trademark Security Agreement and the 2010 Trademark Security Agreement, and any other Trademarks pledged to the Collateral Agent as security pursuant to the Credit Agreement, the "**Trademark Collateral**");

WHEREAS, pursuant to the 2009 Security Agreement, the Grantors executed and delivered that certain Trademark Security Agreement dated as of December 9, 2009 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "**2009 Trademark Security Agreement**");

WHEREAS, pursuant to the 2010 Security Agreement, the Grantors executed and delivered that certain Amended and Restated Trademark Security Agreement dated as of November 24, 2010 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "**2010 Trademark Security Agreement**");

WHEREAS, the 2009 Trademark Security Agreement was recorded on December 11, 2009, with the Trademark Division of the United States Patent and Trademark Office under Reel 4112 and Frame 0522, and the 2010 Trademark Security Agreement was recorded on December 2, 2010, with the Trademark Division of the United States Patent and Trademark Office under Reel 4424 and Frame 0023; and

WHEREAS, in accordance with the provisions of the Credit Agreement, the Grantors have satisfactorily paid all of their obligations under the Credit Agreement and the Collateral Agent now desires to release in its entirety its security interest in, to and under the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all of the Grantors' payment obligations, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

SECTION 1. Release of Security Interest. The Collateral Agent, on behalf of the Secured Parties, hereby absolutely and irrevocably terminates, cancels, assigns and releases to the Grantors any and all of the Collateral Agent's right, title, and interest in and to (including any lien on and/or security interest in) the Trademark Collateral, including, without limitation, the trademarks and trademark applications identified in Schedule A attached hereto. The Collateral Agent hereby acknowledges and agrees that the Security Agreements, the 2009 Trademark Security Agreement and the 2010 Trademark Security Agreement have been terminated.

SECTION 2. Recordation. The Collateral Agent hereby authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.


SECTION 3. Governing Law. This Release shall be construed in accordance with and governed by the laws of the State of New York.
