## NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS

This Notice of Grant of Security Interest in Trademark Rights, dated June 30, 2011 is between **MAC PROCESS INC.**, a Kansas corporation (the “**Security Provider**”) and **COMMERZBANK AKTIENGESELLSCHAFT, FILIALE LUXEMBURG**, a corporation duly organized under and pursuant to the laws of Luxembourg (the “**Security Agent**”).

WHEREAS the Security Provider owns certain rights in the trademarks (the “**Trademarks**”), and/or the trademark applications (the “**Trademark Applications**”), and has certain rights in pa licenses (the “**Trademark Licenses**” and collectively with the Trademarks and the Trademark Applications, the “**Trademark Rights**”), as specifically defined in the attached Schedule of Trademark Rights;

WHEREAS, on or about the date hereof, Security Provider entered into the following agreements:

- an accession letter for the purpose of acceding as an Additional Guarantor to a senior syndicated facility agreement dated 30 October 2007 (as amended on 8 November 2007 and amended and restated 18 February 2011), between, amongst others, Schenck Process Holding GmbH (formerly S-Process Equipment TopCo GmbH) (“**TopCo**”) as the Parent and an Original Guarantor, Schenck Process Finance GmbH (formerly S-Process Equipment AcquiCo GmbH) (“**AcquiCo**”) as the company and an Original Guarantor and an Original Borrower, S-Process Equipment Australia Pty Ltd (“**Oz NewCo**”) as an Original Borrower and Original Guarantor, CIBC World Markets Pic and Dresdner Kleinwort (the investment banking division of Dresdner Bank AG) as the Arranger and Commerzbank Aktiengesellschaft, Filiale Luxemburg as Agent and Security Agent (as amended, amended and restated, supplemented or otherwise modified from time to time, the “**Senior Syndicated Facility Agreement**”) under which the Original Lenders (as defined therein) provided borrowing facilities to AcquiCo (and others) for the purpose (among other things) of AcquiCo's acquisition of the entire issued share capital of Schenck Process Holding GmbH;
- an accession letter for the purpose of acceding as an Additional Guarantor to the mezzanine syndicated facility agreement dated 30 October 2007 (as amended and restated on 8 November 2007 and on 21 February 2011), between, amongst others, TopCo as the Parent and an Original Guarantor, AcquiCo as the company and an Original Guarantor, Oz NewCo as an Original Guarantor, Babson Capital Europe Limited as the Mezzanine Facility Agent and Arranger, Commerzbank Aktiengesellschaft, Filiale Luxemburg as Security Agent, and the Original Lenders (as defined therein) (as amended, amended and restated, supplemented or otherwise modified from time to time, together with the Senior Syndicated Facility Agreement, the “**Facilities Agreements**”);
- an accession letter for the purpose of acceding as an Obligor to an intercreditor agreement dated 30 October 2007 (as amended on 8 November 2007 and as further amended, amended and restated, supplemented or otherwise modified from time to time) between, amongst others, the parties to the Facilities Agreements; and
- an Accession Agreement with Schenck Process Holding North America, Inc. (formerly Provence US One, Inc.), Schenck Accurate Inc., Stock Equipment Company, Inc., and Commerzbank AG for the purpose of acceding to the Security Agreement dated 29 January 2008 between Schenck Process Holding North America, Inc., Schenck Accurate Inc., Stock Equipment Company, Inc., and Dresdner Bank AG, Niederlassung Luxemburg (predecessor in interest to the Security Agent) (as amended,

amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”);

WHEREAS, pursuant to the Facilities Agreements and the Security Agreement, Security Provider is required to execute and deliver to Security Agent, for itself and for the Finance Parties, this Notice of Grant of Security Interest in Trademark Rights.

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Security Provider hereby agrees as follows:

All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.

As security for the prompt and complete payment and performance of the Secured Liabilities when due (whether due because of stated maturity, acceleration, mandatory prepayment, or otherwise) and to induce the Lenders and the Mezzanine Lenders to continue to make the facilities under the Senior Facility Agreement and the facilities under the Mezzanine Facilities Agreement, respectively, available, the Security Provider hereby grants to the Security Agent for the benefit of the Finance Parties a continuing security interest in all of the Security Provider’s right, title and interest in and to all of its Trademarks and Trademark Licenses to which it is a party, including those referred to on Schedule A hereto (as may be amended from time to time) and the proceeds thereof (such as, by way of example, license royalties and proceeds of infringements, all rights corresponding thereto throughout the world) and all renewals and extensions thereof (collectively, the “**Trademark Collateral**”). The Security Agent is authorized to file this Agreement with the United States Patent and Trademark Office or any other governmental agency it deems necessary or desirable in order to secure and perfect its rights under this Notice of Grant of Security Interest in Trademark Rights or the Facilities Agreements.

The Security Provider hereby represents and warrants that, except as permitted under the Facilities Agreements, the Security Provider is the sole legal and beneficial owner of the entire right, title, and interest in and to the Trademark Collateral free and clear of any lien other than the Security Agent’s security interest.

The Security Provider further covenants and agrees to assist the Security Agent, its successors, legal representatives, and assigns to sign all papers and documents, take all lawful oaths, and do all acts necessary or required to be done to perfect and record the security interest contemplated herein.

This Notice of Grant of Security Interest in Trademark Rights shall be governed by the laws of the State of New York.


