CONFIRMATORY TRADEMARK ASSIGNMENT

THIS ASSIGNMENT is made the 12th day of April 2010 by and between Coltec Industries Inc., a Pennsylvania corporation, and Quincy Compressor LLC, a Delaware corporation.

WHEREAS, pursuant to that certain Asset Purchase Agreement dated March 1, 2010, Coltec Industries Inc. transferred certain assets and intellectual property, including the trademark PERFORMANCE YOU DEMAND. RELIABILITY YOU TRUST. (hereinafter, the "Mark") and United States Trademark Application Serial No. 77/911,337 for the Mark (hereinafter, the "Application"), to Fulcrum Acquisition LLC, a Delaware limited liability company;

WHEREAS, Fulcrum Acquisition LLC is the successor to that portion of the ongoing and existing business of Coltec Industries Inc. to which the Mark pertains;

WHEREAS, subsequent to the Asset Purchase Agreement dated March 1, 2010, Fulcrum Acquisition LLC changed its name to Quincy Compressor LLC on March 1, 2010.

WHEREAS, Coltec Industries Inc. wishes to confirm its assignment and transfer of the Mark and the Application, together with the goodwill of the business associated with the Mark and the Application, to Quincy Compressor LLC (by change of name from Fulcrum Acquisition LLC) in a form acceptable for recordation by the United States Patent and Trademark Office.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Coltec Industries Inc. hereby assigns and transfers unto Quincy Compressor LLC (by change of name from Fulcrum Acquisition LLC) all right, title and interest in and to the Mark and the Application, together with the goodwill of the business associated with the Mark and the Application, and together with all claims for damages by reason of past infringement thereof, with the right to sue for, and collect the same for its own use and benefit, and for the use and benefit of its successors, assigns and legal representatives. This confirmatory Assignment is expressly made NUNC PRO TUNC with the same legal force and effect as if executed on March 1, 2010.
