

RELEASE OF TRADEMARK SECURITY INTERESTS dated as of June 29, 2011 (this "Release"), by JPMORGAN CHASE BANK, N.A., as Collateral Agent (the "Collateral Agent"). Capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement or the Guarantee Agreement, as applicable, referred to below.

A. Reference is made to (i) the Credit Agreement dated as of November 23, 2005 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), among Team Health Holdings, L.L.C., ("Holdings"), Team Finance LLC, (the "Borrower"), the lenders party thereto, JPMorgan Chase Bank, N.A., as Administrative Agent (the "Administrative Agent"), (ii) the Guarantee Agreement dated as of November 23, 2005, as supplemented by Supplement No. 1 dated as of June 9, 2006, Supplement No. 2 dated as of June 12, 2007, Supplement No. 3 dated as of June 23, 2008, Supplement No. 4 dated as of April 28, 2009, Supplement No. 5 dated as of August 31, 2009, Supplement No. 6 dated as of February 12, 2010 and Supplement No. 7 dated as of August 5, 2010 (as further amended, supplemented or otherwise modified from time to time, the "Guarantee Agreement"), among Holdings, the Borrower, the Subsidiaries of the Borrower listed therein, (the "Subsidiaries"), and the Administrative Agent (iii) the Intellectual Property Security Agreement dated as of November 23, 2005, as supplemented by Supplement No. 1 dated as of June 9, 2006, Supplement No. 2 dated as of June 12, 2007, Supplement No. 3 dated as of June 23, 2008, Supplement No. 4 dated as of April 28, 2009, Supplement No. 5 dated as of August 31, 2009, Supplement No. 6 dated as of February 12, 2010 and Supplement No. 7 dated as of August 5, 2010 (as further amended, supplemented or otherwise modified from time to time, the "Security Agreement"), among Holdings, the Borrower, the Subsidiaries and the Collateral Agent (iv) the Trademark Security Agreement dated as of November 23, 2005, among Holdings, the Borrower, the Subsidiaries and the Collateral Agent and (v) the Grant of Security Interests in Trademark Rights dated as of February 12, 2010, among Anesthetix Holdings, LLC (a "Subsidiary") and the Collateral Agent (such documents set forth in clauses (i) through (v), the "Security Agreements").

B. Pursuant to the Security Agreements, the Borrower and the Subsidiaries (the "Grantors") granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest in all right, title or interest of the Grantors in the Trademark Collateral, including the trademarks and trademark applications of the Grantors set forth on Schedule I hereto (collectively, the "Trademarks"), which security interests were recorded with the United States Patent & Trademark Office on (i) January 26, 2006 at Reel/Frame 3234/0692, (ii) January 26, 2010 at Reel/Frame 3234/0707, (iii) January 26, 2010 at Reel/Frame 3234/0740, (iv) January 26, 2010 at Reel/Frame 3234/0780, (v) January 26, 2010 at Reel/Frame 3234/0752, (vi) January 26, 2010 at Reel/Frame 3234/0797, (vii) January 26, 2010 at Reel/Frame 3234/0809, (viii) January 26, 2010 at Reel/Frame 3234/0830, (ix) January 26, 2010 at Reel/Frame 3234/0842, (x) January 26, 2010 at Reel/Frame 3234/0885 and (xi) February 26, 2010 at Reel/Frame 4157/0485.

C. Pursuant to the Payoff Letter dated as of June 29, 2011, among Holdings, the Borrower and the Administrative Agent and the Collateral Agent, the Collateral Agent agreed to release any and all security interests it may have in the Trademark Collateral pursuant to the Security Agreements.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent does hereby release, relinquish and discharge any and all security interests it has against the Trademark Collateral. The Collateral Agent agrees to make filings with the United States Patent and Trademark Office and other necessary filings, in each case reasonably requested by the Borrower and at the expense of the Borrower, to evidence the release and termination of the Collateral Agent's security interests in the Trademark Collateral.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK AND SHALL BE BINDING UPON THE COLLATERAL AGENT'S REPRESENTATIVES, SUCCESSORS, ASSIGNS AND TRANSFEREES.
