NOTICE OF PUBLIC SALE

PLEASE TAKE NOTICE THAT Bob King Auctions, agent for Harris N.A., ("*Harris*") will conduct a sale and disposition of the below described collateral by public proceedings in accordance with the provisions of Ill. Rev. Stat. 810 ILCS §5/9-601, *et seq.*, as follows:

(a) *Agreements Pursuant to Which the Sale is Held:* Promissory Note dated October 25, 2007 in the original principal sum of \$1,000,000.00, Commercial Security Agreement dated October 25, 2007 by and between Harris and DeMaco Systems, LLC (the "*Company*"). The Company has defaulted in its obligations to Harris and, accordingly, the aforementioned agreements and applicable law provide for the Notice of Sale set forth herein. Harris has modified the automatic stay in order to realize on the collateral described below.

(b) *Date, Hour and Place of Sale:* October 21, 2008, at 11:00 a.m., local time, at the Company's premises, located at 1141 E. Main Street, Suite 104, East Dundee, Illinois.

(c) *Description of Property to Be Sold:* The property described on Exhibit A hereto, in addition to various mechanical and other drawings, (collectively, the "*Collateral*").

(d) *Terms of Sale:* The property described in paragraph (c) above shall be offered for sale. Payment will be accepted in cash, certified or cashier's check, corporate, partnership or personal check of a corporation, partnership or person resident in North Carolina and presented with a letter of reference from the bank on which the check is drawn, money order, or, in the case of purchase by Harris, credit against amounts due from the Company. As of August 13, 2008, the total amount due Harris from the Company was \$1,005,289.62. Payment must be made in full at the time and place of sale, or within thirty (30) days thereafter. Pursuant to Ill. Rev. Stat. 810 ILCS 5/9-610, and N. C. Gen. Stat. § 25-9-610, Harris retains the right to bid on and purchase the above-described property at the scheduled public sale.

(f) *No Warranties:* The property will be sold "As Is," "WHERE IS," "WITH ALL FAULTS," and "WITHOUT ANY WARRANTIES WHATSOEVER, EXPRESSED OR IMPLIED, INCLUDING, WITHOUT LIMITATION, A WARRANTY OF MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR OR OTHER PURPOSE," and subject to taxes and special assessments, if any have been levied or assessed, and/or unpaid or unsatisfied.




