Trademark Security Agreement

Trademark Security Agreement, dated as of July 6, 2011 by PRO MACH, INC., a Delaware corporation, PRO MACH HOLDINGS, INC., a Delaware corporation, ALLPAX PRODUCTS LLC, a Louisiana limited liability company, AXON LLC, a North Carolina limited liability company, BRENTON LLC, a Minnesota limited liability company, FOWLER PRODUCTS COMPANY, L.L.C., a Delaware limited liability company, ID TECHNOLOGY LLC, a Texas limited liability company, LABELING SYSTEMS LLC, a New Jersey limited liability company, OSSID LLC, a North Carolina limited liability company, OSSID EUROPE, LTD., a North Carolina corporation, PMI EXPORT CORPORATION, a Delaware corporation, RENNCO LLC, a Michigan limited liability company, ROBERTS POLYPRO INC., a South Carolina corporation and SHUTTLEWORTH LLC, an Indiana limited liability company (individually, a "Grantor", and, collectively, the "Grantors"), in favor of BARCLAYS BANK PLC (together with its affiliates, "Barclays"), in its capacity as collateral agent pursuant to the Credit Agreement (in such capacity, the "Collateral Agent").

WITNESSETH:

WHEREAS, the Grantors are party to a Guarantee and Collateral Agreement dated as of July 6, 2011 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Guarantee and Collateral Agreement") in favor of the Collateral Agent pursuant to which the Grantors are required to execute and deliver this Trademark Security Agreement;

NOW, THEREFORE, in consideration of the premises and to induce the Collateral Agent, for the benefit of the Secured Parties, to enter into the Credit Agreement, the Grantors hereby agree with the Collateral Agent as follows:

SECTION 1. Defined Terms. Unless otherwise defined herein, terms defined in the Guarantee and Collateral Agreement and used herein have the meaning given to them in the Guarantee and Collateral Agreement or the Credit Agreement referred to in the Guarantee and Collateral Agreement.

SECTION 2. Grant of Security Interest in Trademark Collateral. Each Grantor hereby pledges and grants to the Collateral Agent for the benefit of the Secured Parties a lien on and security interest in and to all of its right, title and interest in, to and under all the following Pledged Collateral of such Grantor:

- (a) Trademarks of such Grantor listed on Schedule I attached hereto;
 - (b) Trademark Applications of Grantor listed on Schedule I attached hereto (other than Excluded Property);
 - (c) all Goodwill associated with such Trademarks and Trademark Applications;

(d) all Proceeds of any and all of the foregoing (other than Excluded Property).

SECTION 3. Security Agreement. The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Collateral Agent pursuant to the Guarantee and Collateral Agreement and Grantors hereby acknowledge and affirm that the rights and remedies of the Collateral Agent with respect to the security interest in the Trademarks made and granted hereby are more fully set forth in the Guarantee and Collateral Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. In the event that any provision of this Trademark Security Agreement is deemed to conflict with the Guarantee and Collateral Agreement, the provisions of the Guarantee and Collateral Agreement shall control unless the Collateral Agent shall otherwise determine.

SECTION 4. Termination. Upon the payment in full of the Secured Obligations and termination of the Guarantee and Collateral Agreement, the Collateral Agent shall execute, acknowledge, and deliver to the Grantors an instrument in writing in recordable form releasing the collateral pledge, grant, assignment, lien and security interest in the Trademarks under this Trademark Security Agreement.

SECTION 5. Counterparts. This Trademark Security Agreement may be executed in any number of counterparts, all of which shall constitute one and the same instrument, and any party hereto may execute this Trademark Security Agreement by signing and delivering one or more counterparts.
