FULL RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, NUDO PRODUCTS, INC. (as successor-by-merger to NPI Merger Sub, Inc.) and NPI HOLDING CORP. (collectively, the "Debtor"), granted to NEWSTAR FINANCIAL, INC., as Administrative Agent, with offices at 500 Boylston Street, Suite 1600, Boston, Massachusetts 02116 (the "Secured Party") a security interest in, among other things, certain of the Debtor's trademarks listed on Schedule I attached hereto (the "Subject Trademarks") pursuant to a certain agreement (the "Agreement"), which was filed at the United States Patent and Trademark Office on January 22, 2009 and recorded on Reel 3923, Frame 0549;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged: the Secured Party hereby (1) terminates, releases and discharges fully its security interest in the Subject Trademarks, (2) reassigns to the Debtor all right, title, and interest that it may have in the Subject Trademarks, including the goodwill associated with the Subject Trademarks, any and all applications or registrations therefor, and the right to sue for past, present and future infringements, and the proceeds thereof, including, without limitation, license royalties and proceeds of infringement suits, (3) acknowledges and agrees that any right, title or interest of Secured Party in the intellectual property of the Debtor, including the Subject Trademarks, does hereby cease and become void, and (4) authorizes the Debtor or the Debtor's agents or designees to record this Release with the United States Patent and Trademark Office.
