**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

WHEREAS AmQuip Crane Rental LLC, a Delaware limited liability company with an address at 1150 Northbrook Drive, Suite 100, Trevoose, PA 19053 (the "Grantor"), certain of its subsidiaries, and AmQuip Holdings LLC, a Delaware limited liability company, entered into that certain security agreement dated June 29, 2007 (the "Security Agreement") with Deutsche Bank Trust Company Americas, a national banking corporation with an address at 60 Wall Street, New York, NY 10005 (the "Collateral Agent"), notice of which was recorded July 16, 2007 at the United States Patent and Trademark Office at Reel 3580, Frame 0672.

WHEREAS, Grantor granted the Collateral Agent, under the terms of the Security Agreement, a continuing security interest (the "Security Interest") in favor of the Collateral Agent, in and to certain of Grantor's intellectual property, including without limitation the trademarks listed in Schedule A (collectively, the "Trademarks") and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademarks as herein provided.

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges all liens and the Security Interest, hereby waives and relinquishes all its rights, powers, privileges and remedies with respect to Grantor and its successors and assigns in association with the Security Interest, and hereby releases Grantor and its successors and assigns from all covenants, obligations, liabilities and warranties in association with the Security Interest.
