**RELEASE OF INTELLECTUAL PROPERTY  
(TRADEMARKS)**

Release of Intellectual Property (this "Release"), dated as of the 30<sup>th</sup> day of September, 2011, made by THL Corporate Finance, Inc. (the "Collateral Agent"), in favor of SiVance, LLC (the "Pledgor").

R E C I T A L S

A. The Pledgor and Collateral Agent entered into a certain Trademark Assignment of Security, dated as of February 17, 2011 (the "Agreement"), pursuant to which the Pledgor granted to the Collateral Agent a lien on and security interest in certain intellectual property collateral owned by the Pledgor; capitalized terms used herein and not defined shall have the meanings set forth in the Agreement. The Collateral Agent recorded an assignment document with respect to the Trademarks with the Assignments Division of the United States Patent & Trademark Office on February 22, 2011 at Reel 004484, Frame 0086.

B. In accordance with the terms of the Agreement, the Pledgor has satisfied all of its outstanding obligations under the Agreement and, in connection therewith, the Pledgor has requested Collateral Agent to release, and Collateral Agent has agreed to release, its lien on all Trademarks pledged pursuant to the Agreement.

Collateral Agent hereby releases and terminates all right, title and interest pledged, hypothecated, assigned, transferred, deposited and granted to it by the Pledgor pursuant to the Agreement in all Patents and Trademarks, including without limitation, the Trademarks identified on Exhibit A annexed hereto (collectively, the "Released Collateral"), and all liens, security interests, charges or other encumbrances in favor of Collateral Agent in the Released Collateral shall hereby terminate and revert to the Pledgor and all right, title and interest of Collateral Agent in the Released Collateral will hereby cease, terminate and become void.

This Release may be executed in one or more counterparts, each of which shall be an original and all of which, taken together, shall constitute one and the same instrument.
