**RELEASE OF GRANT OF TRADEMARK SECURITY INTEREST**

**THIS RELEASE OF GRANT OF TRADEMARK SECURITY INTEREST** (this "Release") is made as of September 30, 2011 (the "Effective Date") by Bank of America, N.A., as agent for the benefit of the Lenders (as such terms is referenced under the Grant of Trademark Security Interest referred to below) (in such capacity, the "Agent") in favor of Levi Strauss & Co., a Delaware corporation (the "Grantor").

**WHEREAS**, pursuant to the terms and conditions set forth in that certain Trademark Security Agreement between the Grantor and the Agent, dated as of October 11, 2007 (the "Trademark Security Agreement"), the Grantor granted to the Agent a security interest and lien in all of such Grantor's right, title and interest in the Collateral (as defined in the Trademark Security Agreement);

**WHEREAS**, pursuant to the Trademark Security Agreement, the Grantor executed in favor of the Agent a Grant of Trademark Security Interest, dated October 11, 2007, and subsequent Trademark Supplements, which Grant of Trademark Security Interest and Trademark Supplements were recorded with the Trademark Division of the U.S. Patent & Trademark Office on October 11, 2007 at Reel 3637 and Frame 0893, on March 19, 2008 at Reel 3743 and Frame 0396, on September 15, 2010 at Reel 4278 and Frame 0634, on January 14, 2011 at Reel 4453 and Frame 0336, on March 16, 2011 at Reel 4498 and Frame 0761, on June 22, 2011 at Reel 4567 and Frame 0437, and on August 31, 2011 at Reel 4614 and Frame 0750;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates the Trademark Security Agreement, the Grant of Trademark Security Interest and all Trademark Supplements, and hereby irrevocably terminates, cancels, re-pledges, reassigns and releases any and all security interests and liens it has against the Collateral, including those trademark registrations and trademark applications listed under Schedule I attached hereto (collectively, the "Trademarks").

If and to the extent the Agent has acquired any right, title or interest to any of the Trademarks, it hereby re-assigns and re-transfers such rights, title or interest to the Grantor, along with all of the goodwill represented by such Trademarks.

The Agent shall take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor to more fully and effectively effectuate the purposes of this Release, all at the expense of the Grantor.
