**SECURITY INTEREST IN TRADEMARKS**

This **SECURITY INTEREST IN TRADEMARKS** ("Agreement") is made as of June 24, 2011 by each of **ORNAMENTAL MOULDINGS, LLC, THE EMPIRE COMPANY, INC., ORNAMENTAL MOULDINGS COMPANY** and **TENON LIMITED** (collectively, the "Grantors") in favor of **JPMORGAN CHASE BANK, NA**, a national banking association, having an office at 1300 East Ninth Street, 13th Floor, Cleveland, Ohio 44114, in its capacity as administrative agent for the lenders party to the Credit Agreement referred to below (the "Agent").

WHEREAS, each Grantor entered into that certain Credit Agreement dated as of date hereof (as from time to time, amended, modified, or supplemented, the "Credit Agreement") (all capitalized terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement), between each Grantor, the Agent, the other Loan Parties and the Lenders, pursuant to which the Lenders made certain financial accommodations available to the Borrowers;

WHEREAS, to secure the performance of its obligations under the Credit Agreement, each Grantor entered into a Pledge and Security Agreement dated as of the date hereof, by which such Grantor granted to the Agent, for the benefit of the Lenders, a security interest in and to all trademarks, trademark registrations and applications and the goodwill symbolized thereby currently owned by the Grantor or acquired by such Grantor after such date; and

WHEREAS, each Grantor is the owner of the trademarks, trademark registrations and applications listed next to such Grantor's name on Exhibit A, and the goodwill symbolized thereby, and the parties wish to document the security interest granted to Agent, for the benefit of the Lenders, with respect thereto;

NOW THEREFORE, each Grantor hereby grants to the Agent, for the benefit of the Lenders, a security interest in and to the trademarks, trademark registrations and applications listed in Exhibit A, and authorizes and requests the Commissioner of Patents and Trademarks of the United States of America and the empowered officials of all other governments to note in the record the existence of the security interest granted hereunder with respect to each of the trademark registrations and applications listed in Exhibit A.
