**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "**Release**"), dated as of October 19, 2011, is made by **BANK OF AMERICA**, as Agent (the "**Agent**"), under the Loan and Security Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Loan and Security Agreement).

WHEREAS, in connection with that certain Amended and Restated Credit Agreement, dated as of April 30, 2010 (as amended, restated, supplemented or otherwise modified from time to time, and together with all general security agreements, trademark security agreements and patent security agreements entered into in connection therewith or in connection with prior versions thereof, the "**Credit Agreement**"), among **KELLWOOD COMPANY** (the "**Borrower Representative**" or "**Parent**") and its Domestic Subsidiaries from time to time a party hereto (each a "**Borrower**" and collectively with Borrower Representative, "**Borrowers**") the other Loan Parties signatory thereto, the Agent, and the Lenders signatory thereto from time to time (each individually a "**Lender**," and collectively, the "**Lenders**"), the Lenders made credit extensions to the Borrowers;

WHEREAS, in connection with the Loan and Security Agreement, and pursuant to those certain agreements described on Annex I attached hereto (collectively, the "**Security Agreements**"), the Borrowers and the Loan Parties granted security interests in certain intellectual property owned by the Borrowers and the Loan Parties including those listed on Annex I attached hereto (collectively, the "**Intellectual Property Collateral**"); and

WHEREAS, the Security Agreements were recorded in the U.S. Patent and Trademark Office on the dates and on the reels and frames set forth on Annex I hereto;

NOW THEREFORE, the Agent hereby **RELEASES**, without representation, recourse or warranty whatsoever, all of its security interest in the Intellectual Property Collateral, whether granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Loan and Security Agreement, and the Agent hereby reassigns any and all such right, title and interest (if any) that the Agent may have in the Intellectual Property Collateral to the Borrowers and the Loan Parties, respectively.

The Agent agrees, at the Borrowers' and the Loan Parties' expense, to cooperate with the Borrowers and the Loan Parties and to provide the Borrowers and the Loan Parties with the information and additional authorization reasonably required or desirable to effect the release of the Agent's security interest in the released collateral described herein.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
