TO THE
ARTICLES OF INCORPORATION
OF

The name of the Corporation is VPI Corporation.

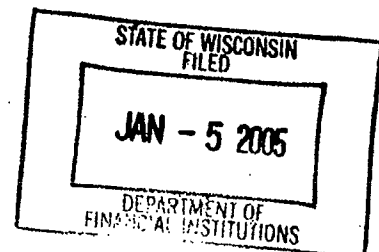
