## INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (this “**IP Assignment Agreement**”) is made and entered into as of October 31, 2011 by and among The Homax Group, Inc., a Delaware corporation (“**Parent**”), Homax BF Holdings Corp., a Delaware corporation (“**Homax**”), Homax Products, Inc., a Delaware corporation (“**HPI**”), Black Flag Brands, LLC, a New York limited liability company (“**Brands**”), and BF Products, LLC, a Delaware limited liability company (“**Products**” and, together with Homax, HPI, and Brands, each a “**Seller**” and, collectively, “**Sellers**”); and United Industries Corporation, a Delaware corporation (“**Buyer**”).

WHEREAS, Parent, Sellers, and Buyer have entered into that certain Asset Purchase Agreement, dated as of October 14, 2011 (the “**Purchase Agreement**”), pursuant to which Parent and Sellers have agreed to sell and assign to Buyer, and Buyer has agreed to purchase and assume from Parent and Sellers, certain the assets, and certain specified liabilities, of the Business (as such term is defined in the Purchase Agreement), all as more fully described therein;

WHEREAS, under the terms of the Purchase Agreement, Parent and Sellers have conveyed, transferred and assigned to Buyer, among other assets, certain intellectual property assets of Parent and Sellers, and have agreed to execute and deliver this IP Assignment Agreement, for recording with governmental authorities including, but not limited to, the United States Patent and Trademark Office;

WHEREAS, this is the form of Intellectual Property Assignment form referred to as Exhibit E in the Purchase Agreement; and

WHEREAS, the execution and delivery of this IP Assignment Agreement is a material condition to the parties’ obligations under the Purchase Agreement.

NOW, THEREFORE, in consideration of the mutual agreements and covenants hereinafter set forth, Parent, Buyer and Sellers hereby agree as follows:

### ARTICLE I

1. Assignment. In consideration for the execution of the Purchase Agreement, the payment of the consideration stipulated in the Purchase Agreement and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Parent and Sellers hereby irrevocably convey, transfer and assign to Buyer, and Buyer hereby accepts, all of Parent’s and each Seller’s rights, title and interest in and to the following intellectual property assets (the “**Assigned IP**”):

(a) the patents and patent applications set forth in Schedule 1 hereto and any and all applications or patents derived therefrom, including, but not limited to divisions, continuations, continuations-in-part, reissues, extensions, reexaminations and renewals thereof, wherever located (the “**Patents**”);

(b) the trademark registrations and applications set forth in Schedule 2 hereto, together with the goodwill connected with the use of and symbolized thereby, and all corresponding applications and registrations, extensions and renewals thereof, wherever located (the “**Trademarks**”), including, without limitation, the right to renew any registrations for the Trademarks, the right to apply for trademark registrations within or outside the United States based in whole or in part upon the Trademarks, and any priority right that may arise from the Trademarks;

(c) all rights of any kind whatsoever of Parent and Sellers, or any of them, accruing under any of the foregoing Assigned IP provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;

(d) any and all royalties, fees, income, payments and other proceeds hereafter due or payable with respect to any and all of the foregoing Assigned IP; and

(e) any and all claims and causes of action, with respect to any of the foregoing Assigned IP, whether accruing before, on and/or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Recordation and Further Actions. Parent and Sellers authorize the Commissioner for Patents for the United States and the Commissioner for Trademarks for the United States and any other governmental officials and in any applicable jurisdictions outside the United States to record and register this IP Assignment Agreement upon request by Buyer and at Buyer’s expense. Parent and Sellers shall take such steps and actions following the date hereof, including the execution of any documents, files, registrations, or other similar items, upon request by Buyer and at Buyer’s expense, as reasonably necessary to ensure that the Assigned IP is properly assigned to Buyer, and that the records of all applicable jurisdictions duly record Buyer’s ownership of the same.

3. Terms of the Purchase Agreement. The terms of the Purchase Agreement, including, but not limited to, the representations, warranties, covenants, agreements and indemnities relating to the Assigned IP are incorporated herein by this reference. The parties hereto acknowledge and agree that the representations, warranties, covenants, agreements and indemnities contained in the Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Purchase Agreement and the terms hereof, the terms of the Purchase Agreement shall govern.

4. Counterparts. This IP Assignment Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this IP Assignment Agreement delivered by e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this IP Assignment Agreement.

5. Successors and Assigns. This IP Assignment Agreement shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.


6. Governing Law. This IP Assignment Agreement and any claim, controversy, dispute or cause of action (whether in contract, tort or otherwise) based upon, arising out of or relating to this IP Assignment Agreement and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Delaware, without giving effect to any choice or conflict of law provision or rule (whether of the State of Delaware or any other jurisdiction).
