**RELEASE OF
SECURITY INTEREST IN U.S. TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN U.S. TRADEMARKS, dated as of September 1, 2011 (this "Release"), is made and entered into by PNC Bank, National Association, as Agent (as hereinafter defined), for the Lenders (as hereinafter defined) under that certain Patent, Trademark and Copyright Security Agreement, dated June 22, 2007 (the "Agreement"), made by Resco Products, Inc., a Pennsylvania corporation (the "Borrower"), in connection with that certain First Lien Credit Agreement, dated June 22, 2007, among the Borrower, the Guarantors (as defined in the Credit Agreement), PNC Bank, National Association ("PNC Bank") and various other financial institutions from time to time (PNC Bank, and such other financial institutions are each, a "Lender" and collectively, the "Lenders"), and PNC Bank, as agent for the Lenders (in such capacity, the "Agent") (as amended, modified or supplemented from time to time, the "Credit Agreement").

Capitalized terms used herein and not otherwise defined herein shall have the meanings assigned thereto in the Credit Agreement.

WHEREAS, pursuant to the Agreement, the Borrower granted to the Agent a Lien on all right, title and interest of the Borrower in and to the registered Trademarks set forth on Schedule A attached hereto and made a part hereof (the "Trademarks"), and the Borrower executed that certain Notice of Security Interest – U.S. Trademarks on June 22, 2007, which the Agent filed on June 28, 2007, in the United States Patent and Trademark Office, at Reel/Frame: 003574/0421; and

WHEREAS, the Agent has agreed to release, relinquish, terminate and discharge its right, title and interest in the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. The Agent hereby releases, relinquishes, terminates and discharges in its entirety any and all Lien or security interest it has in the Trademarks. All rights, title and interest in and to such Trademarks, including, without limitation, the right to sue for past, present and future infringement, hereby reverts to the Borrower.
2. The Agent authorizes and requests the United States Patent and Trademark Office to record this Release against such Trademarks, as applicable.
3. The Agent hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purpose of this Release.
