## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE (this "Trademark Release") is made as of November 30, 2011 from Credit Suisse AG (formerly known as Credit Suisse and successor to Lehman Commercial Paper Inc.) ("CS"), as Administrative Agent (as defined below) for the Secured Parties (as defined in the Guarantee and Collateral Agreement referred to below), to B&G Foods North America, Inc. (formerly known as Burnham & Morrill Company (formerly known as Heritage Acquisition Corp., as successor-in-interest to Ortega Holdings, Inc. and Maple Grove Farms of Vermont, Inc.), as successor-in-interest to Bloch & Guggenheimer, Polaner, Inc., and Trappey's Fine Foods, Inc.), William Underwood Company, and B&G Foods, Inc. (collectively and, together with their permitted successors and assigns, the "Grantors"). Unless otherwise defined herein, terms defined in the Credit Agreement (as defined below) or in the Guarantee and Collateral Agreement and used herein have the meaning given to them in the Credit Agreement or the Guarantee and Collateral Agreement, as the case may be.

WHEREAS, pursuant to that certain Credit Agreement, dated as of October 15, 2004 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among B&G Foods, Inc. (the "Borrower"), the lenders from time to time party thereto (the "Lenders"), Lehman Brothers Inc., as arranger, The Bank of New York, as documentation agent, Fleet National Bank, a Bank of America company, as syndication agent, and Credit Suisse AG (formerly known as Credit Suisse and successor to Lehman Commercial Paper Inc.), as administrative agent (in such capacity, the "Administrative Agent") the Lenders agreed to make extensions of credit to the Borrower upon the terms and subject to the conditions set forth therein;

WHEREAS, the Grantors are party to that certain Guarantee and Collateral Agreement, dated as of October 15, 2004, in favor of the Administrative Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Guarantee and Collateral Agreement");

WHEREAS, in connection with the Guarantee and Collateral Agreement, the Grantors executed that certain Intellectual Property Security Agreement, dated October 15, 2004 (as the same may be or may have been amended, restated or amended and restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement") pursuant to which the Grantors granted to the Administrative Agent, for the benefit of the Secured Parties, a security interest in the Trademark Collateral (as defined below);

WHEREAS, the (i) the Intellectual Property Security Agreement made by B&G Foods, Inc. and recorded in the U.S. Patent and Trademark Office on October 21, 2004 at Reel/Frame No. 2960/0532, (ii) the Intellectual Property Security Agreement made by Burnham & Morrill Company (f/k/a Heritage Acquisition Corp.) and recorded in the U.S. Patent and Trademark Office on October 21, 2004 at Reel/Frame No. 2960/0646, (iii) the Intellectual Property Security Agreement made by Burnham & Morrill Company, as successor-in-interest to Ortega Holdings, Inc and recorded in the U.S. Patent and Trademark Office on October 21, 2004 at Reel/Frame No. 2960/0561, (iv) the Intellectual Property Security Agreement made by Burnham & Morrill Company, as successor-in-interest to Maple Grove Farms of Vermont, Inc. and recorded in the U.S. Patent and Trademark Office on October 21, 2004 at Reel/Frame No. 2960/0634, (v) the Intellectual Property Security Agreement made by Bloch & Guggenheimer, as successor-in-interest to Trappey's Fine Foods, Inc. and recorded in the U.S. Patent and Trademark Office on October 21, 2004 at Reel/Frame No. 2960/0626, (vi) the Intellectual Property



Security Agreement made by Bloch & Guggenheimer, Inc. and recorded in the U.S. Patent and Trademark Office on October 21, 2004 at Reel/Frame No. 2960/0568, (vii) the Intellectual Property Security Agreement made by Polaner, Inc. and recorded in the U.S. Patent and Trademark Office on October 21, 2004 at Reel/Frame No. 2960/0539, and (viii) the Intellectual Property Security Agreement made by William Underwood Company and recorded in the U.S. Patent and Trademark Office on October 21, 2004 at Reel/Frame No. 2960/0581, each dated as of October 15, 2004 in favor of the Existing Agent, and (ix) the Intellectual Property Security Agreement made by Bloch & Guggenheimer, Inc. and recorded in the U.S. Patent and Trademark Office on January 11, 2006 at Reel/Frame No. 3225/0363 dated January 10, 2006 in favor of the Administrative Agent;

WHEREAS, pursuant to certain amendments to the Credit Agreement and the Security Agreement, (i) Lehman Commercial Paper Inc. was replaced by CS as administrative agent under the Credit Agreement and the Guarantee and Collateral Agreement, and consequently CS acquired all of the Lehman Commercial Paper Inc.'s right, title and interest, as administrative agent, in the Trademark Collateral;

WHEREAS, the (i) Supplemental IP Security Interest in B&G Foods, Inc.'s trademarks was recorded in the U.S. Patent and Trademark office on August 18, 2009 at Reel/Frame 4047/0818, (ii) Supplemental IP Security Interest in Burnham & Morrill Company's trademarks was recorded in the U.S. Patent and Trademark office on August 18, 2009 at Reel/Frame 4047/0875, (iii) Supplemental IP Security Interest in Polaner, Inc.'s trademarks was recorded in the U.S. Patent and Trademark office on August 18, 2009 at Reel/Frame 4047/0882 in favor of the Administrative Agent;

WHEREAS, the Supplemental IP Security Interest in B&G Foods North America, Inc.'s trademarks was recorded in the U.S. Patent and Trademark office on March 23, 2011 at Reel/Frame 4503/0750 in favor of the Administrative Agent;

WHEREAS, the Administrative Agent, now desires to terminate and release the entirety of its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Trademark Release, the Administrative Agent, and the Grantors hereby agree as follows:

SECTION 1. Trademark Collateral. The term "Trademark Collateral," as used herein, shall mean:

(a) all of the Grantor's Trademarks and Trademark Licenses to which the Grantors are a party, referred to on Schedule I hereto;

(b) all goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(c) all Proceeds of the foregoing, including, without limitation, any claim by the Grantors against third parties for past, present, future (i) infringement or dilution of any Trademark or Trademark licensed under any Trademark License or (ii) injury to the goodwill associated with any Trademark or any Trademark licensed under any Trademark License.


SECTION 2. Release of Security Interest. The Administrative Agent, hereby terminates, releases and discharges its security interest in the Trademark Collateral. The Administrative Agent agrees, at the Borrower's expense, to cooperate with the Borrower and to provide the Borrower with the information and additional authorization necessary to effect the release of its security interest in the Trademark Collateral.

SECTION 3. Recordation. The Administrative Agent, authorizes the recordation of this Trademark Release with the United States Patent and Trademark Office and any other applicable registry.

SECTION 4. Applicable Law. This Trademark Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the law of the State of New York.




