**RELEASE OF FIRST LIEN SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of December 1, 2011, is made by UBS AG, Stamford Branch (“Lender”), in favor of The GSI Group, LLC fka The GSI Group, Inc. (“Company”) as follows:

WITNESSETH

WHEREAS, pursuant to the First Lien Trademark Security Agreement, dated August 1, 2007 and recorded with The United States Patent and Trademark Office on August 8, 2007 at Reel/Frame No. 3596/0987, and the First Lien After-Acquired Trademark Security Agreement, dated May 13, 2009, and recorded with The United States Patent and Trademark Office on May 20, 2009 at Reel/Frame No. 3990/0660 (collectively, the “Security Agreement”), Company granted Lender a security interest in and to all of Company’s right, title and interest in certain trademarks and applications and registrations therefor, including goodwill (the “Trademark Collateral”);

WHEREAS, Company has requested that Lender release its security interest in and to the Trademark Collateral, including without limitation the trademarks and all applications and registrations therefor set forth in Schedule A attached hereto and incorporated herein by reference.

NOW, THEREFORE, Lender, without recourse, representation or warranty and at Company’s sole cost and expense, hereby RELEASES all of its right, title and interest in and to the Trademark Collateral, including without limitation the trademarks set forth in Schedule A and any other collateral described in the Security Agreement.
