Canadian Registration No. TMA398605



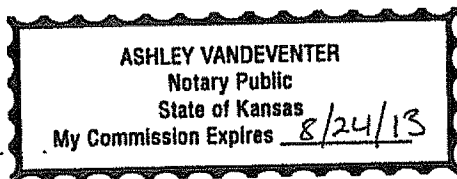
