**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN PATENTS AND TRADEMARKS**

WHEREAS ROSENBLUTH INTERNATIONAL, INC., a Pennsylvania corporation (the "Grantor"), entered into that certain security agreement dated June 21, 2001 (the "Security Agreement") with JPMORGAN CHASE BANK, NATIONAL ASSOCIATION, formerly known as JPMorgan Chase Bank, formerly known as The Chase Manhattan Bank, a national banking association (the "Agent"), notice of which was recorded July 11, 2001 with the trademark division of the United States Patent and Trademark Office at Reel 002327, Frames 0458-0485, and recorded June 29, 2001 with the patent division of the United States Patent and Trademark Office at Reel 011944, Frame 0513.

WHEREAS, Grantor granted the Agent, under the terms of the Security Agreement, a continuing security interest in favor of the Agent in and to certain of Grantor's intellectual property (the "Security Interest"), including without limitation the trademarks listed in Schedule A hereto (collectively, the "Trademarks"), the patents listed in Schedule B hereto (collectively, the "Patents," and, with the Trademarks, the "Intellectual Property") and all of the goodwill of the business connected with the use of, and symbolized by, the Intellectual Property.

WHEREAS, the Agent has agreed to terminate and release its security interest in all such Intellectual Property as herein provided.

NOW, THEREFORE, in consideration of the foregoing, the Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges the Security Interest, hereby waives and relinquishes all its rights, powers, privileges and remedies with respect to Grantor and its successors and assigns in association with the Security Interest, and hereby releases Grantor and its successors and assigns from all covenants, obligations, liabilities and warranties in association with the Security Interest.
