U.S. TRADEMARK ASSIGNMENT

This Trademark Assignment is effective as of the 6th day of December 2011, by and between ELIZABETH ARDEN, INC. ("Arden") and AVON PRODUCTS, INC. ("API").

WHEREAS, Assignor has agreed to assign to Assignee, its entire right, title and interest in and to the UNPLUGGED Trademark and the related goodwill; and


NOW, THEREFORE, for good and valuable consideration, receipt of which is acknowledged, effective as of the date first written above, Assignor does hereby assign and transfer unto Assignee, all its right, title and interest in and to the UNPLUGGED Trademark for all goods and services, including but not limited to "Non-medicated skin care preparations, namely, pore refining facial masks" together with U.S. Reg. No. 2,878,012 therefor, and the related goodwill of the business symbolized by and associated with said UNPLUGGED Trademark.
