RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of January 19, 2012 ("Effective Date") in favor of COMFORCE CORPORATION, a Delaware corporation, ("Grantor"), by PNC BANK, NATIONAL ASSOCIATION (the "Administrative Agent").

WHEREAS, Grantor and the Administrative Agent entered into that certain Revolving Credit and Security Agreement by and between Grantor, the Administrative Agent and the other parties thereto, dated June 25, 2003 (the "Revolving Credit and Security Agreement");

WHEREAS, pursuant to the Revolving Credit and Security Agreement, Grantor granted to the Administrative Agent a security interest in all of their right, title and interest in, to and under certain intellectual property and entered into (a) that certain Trademark Security Agreements dated June 25, 2003 (the "June 2003 Trademark Security Agreement") and (b) that certain Amended and Restated Trademark Security Agreement, dated November, 2, 2009 (the "2009 Trademark Security Agreement"), for the purpose of recording such security interest with respect to the trademarks of Grantor, including those items set forth on Schedule A hereto (as further defined in the foregoing trademark security agreements, the "Trademark Collateral") with the United States Patent and Trademark Office;

WHEREAS, the June 2003 Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 14, 2003, at Reel 2781, Frame 0198, and the 2009 Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November, 2, 2009 , at Reel 4089, Frame 0418, and

WHEREAS, Grantor has paid all of its outstanding indebtedness (other than certain contingent and expense reimbursement obligations) to the Administrative Agent.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby (i) terminates (A) the 2003 Trademark Security Agreement and (B) the 2009 Trademark Security Agreement, (ii) terminates, cancels and releases any and all security interests it has against the Trademark Collateral, and (iii) re-assigns to Grantor any right, title and interest it may have in, to and under the Trademark Collateral to Grantor.


This Release shall be governed by and construed in accordance with the laws of the State of New York.
