TRADEMARK ASSIGNMENT

WHEREAS, West Point Products, LLC, an Ohio limited liability company ("Assignor"), has adopted and used and is the exclusive owner of the trademark registrations listed on the attached Schedule A (the "Trademarks"); and

WHEREAS, pursuant to the Asset Purchase Agreement ("Purchase Agreement") dated April 14, 2010, Assignor sold all of its trademarks, including the Trademarks listed in Schedule A to West Point Acquisition, LLC, a Delaware limited liability company ("Assignee").

Assignor hereby authorizes and requests any official throughout the world whose duty it is to register and record ownership in intellectual property rights, including the Patent & Trademark Office of the United States, to record Assignee as the assignee and owner of the Trademarks.

Upon reasonable notice given by Assignee, Assignor hereby agrees to execute and deliver at a future date any additional documents that Assignee determines may be necessary or desirable, or that may be required under federal or state law, to preserve and protect, and to perfect Assignee's ownership of, the Trademarks and the Goodwill. Assignor further agrees to pay any filing or other governmental fees and charges that become due and payable prior to the date hereof in connection with the registration of any of the Trademarks.


This Trademark Assignment shall be binding upon and shall inure to the benefit of the respective successors and assigns of Assignor and Assignee.
