RELEASE OF SECURITY INTEREST IN TRADEMARKS

NOW THEREFORE, Secured Party hereby notifies, acknowledges to and agrees with Grantor that the security interest in the Trademarks granted by Grantor to Secured Party pursuant to the terms of the Grant of Security, is terminated and released as of the date hereof, and that Secured Party hereby releases and forever discharges all of its right, title and interest of any kind or nature granted, assigned or conveyed pursuant to the Grant of Security in and to the Trademarks.

Secured Party hereby agrees to take such further actions and to execute such further documents as Grantor may reasonably request to effect and evidence this Release, including, without limitation, the execution of any filings, statements, amendments, recordations or other instruments required to maintain the application or registration of the Trademarks and record the chain of title accordingly with the United States Patent and Trademark Office.
