Capitalized terms used but not defined herein shall have the meanings ascribed to such terms in the 2005 Trademark Security Agreement, 2008 Trademark Security Agreement or 2011 Trademark Security Agreement, as applicable (each as defined below).

W I T N E S S E T H:

WHEREAS, the 2005 Trademark Security Agreement was recorded with the United States Patent and Trademark Office on September 1, 2005 at Reel/Frame 3152/0033;

WHEREAS, Hanley-Wood and Assignor are parties to that certain Trademark Security Agreement, dated as of October 23, 2008 (the "2008 Trademark Security Agreement"), pursuant to which, as security for the payment or performance, as the case may be, in full of the Obligations, Hanley-Wood granted to Assignor, its successors and assigns, for the benefit of the Secured Parties, a security interest in all right, title or interest in or to any and all of the following assets and properties then owned or at any time thereafter acquired by Hanley-Wood or in which Hanley-Wood then had or at any time thereafter may have acquired any right, title or interest (collectively, the "2008 Trademarks"): (a) all trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, then existing or thereafter adopted or acquired, all registrations and recordings thereof, and all registration and recording applications filed in connection therewith, including registrations and registration applications in the United States Patent and Trademark Office or any similar offices in any State of the United States or any other country or any political subdivision thereof, and all extension or renewals thereof, including those listed on Schedule II attached hereto; (b) all goodwill associated with or symbolized thereby; and (c) all assets, rights and interest that uniquely reflect or embody the foregoing;

WHEREAS, the 2008 Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 12, 2008 at Reel/Frame 3886/0617;

WHEREAS, Hanley-Wood and Assignor are parties to that certain Supplement, dated as of January 7, 2011 to the 2005 Trademark Security Agreement (the "2011 Trademark Security Agreement"), pursuant to which, as security for the payment in full of the Obligations, Hanley-Wood granted to Assignor, its permitted successors and assigns, for the benefit of the Secured Parties, a security interest in all right, title or interest in or to any and all of the trademarks and trademark applications listed on Schedule III attached hereto, including the goodwill of the business connected with the use thereof and symbolized thereby (the "2011 Trademarks", and together with the 2005 Trademarks and the 2008 Trademarks, the "Trademark Collateral");

WHEREAS, the 2011 Trademark Security Agreement was recorded with the United States Patent and Trademark Office on February 3, 2011 at Reel/Frame 4467/0141; and

WHEREAS, Assignor and Assignees desire that Assignor terminate and release its security interest in all right, title or interest of Assignees in or to the Trademark Collateral.

NOW, THEREFORE, in consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignees hereby agree as follows:

Assignor hereby terminates, releases and discharges fully, without representation, warranty or recourse, its security interest in all right, title or interest of Assignees in or to the Trademark Collateral listed on Schedules I, II and III attached hereto, and reassigns and transfers any right, title or interest that Assignor may have in the Trademark Collateral to Assignees.
