RELEASE OF US SECURITY INTERESTS

This Release of US Security Interests (this "**Release**") is effective as of June 16, 2011, by The Royal Bank of Scotland plc, as Security Agent for the Secured Creditors (in such capacity, the "**Security Agent**"), for the benefit of Global Licensing Company, LLC (the "**Grantor**"). Except as otherwise defined herein, terms used herein and defined in the Security Agreement (as defined below) shall be used herein as therein defined.

WITNESSETH:

WHEREAS, Vespucci Sub Finance S.à.r.l., the Grantor, the borrowers from time to time party thereto (each, a "**Borrower**", and collectively, the "**Borrowers**"), the guarantors from time to time party thereto, The Royal Bank of Scotland plc, as mandated lead arranger, facility agent, security agent and swingline agent and the financial institutions from time to time party thereto have entered into a senior facilities agreement, dated October 23, 2007, as amended and restated on December 6, 2007 and May 30, 2008, and as further amended and restated pursuant to an amendment and restatement agreement dated September 2, 2009, providing, inter alia, for the making of Loans to, and the issuance of, and participation in, Letters of Credit for the respective accounts of the Borrowers, all as contemplated therein (as used herein, the term "**Senior Facilities Agreement**" means the Senior Facilities Agreement described above in this paragraph, as the same may from time to time be further amended, restated, modified and/or supplemented);

WHEREAS, in order to secure its obligations under the Senior Facilities Agreement, the Grantor entered into a Security Agreement, dated as of October 23, 2007 in favor of the Security Agent, as the same may be amended, modified, restated and/or supplemented from time to time (the "**Security Agreement**"), pursuant to which the Grantor had granted a continuing security interest to the Security Agent, for its benefit and for the benefit of the Secured Creditors, in certain intellectual property collateral of the Grantor, including but not limited to that set forth on Schedule I hereto (the "**IP Collateral**"), which security was recorded with the United States Patent and Trademark Office at Reel 003668 / Frame 0874, on November 29, 2007;

WHEREAS, in connection with the termination of the Senior Facilities Agreement, the Grantor has informed the Security Agent of its desire to obtain the release of all rights, title and interest of the Security Agent in and to the IP Collateral granted under the Security Agreement; and

WHEREAS, the Secured Creditors have consented to the release of the security interest over the IP Collateral.

NOW, THEREFORE, in consideration of the foregoing and for other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Security Agent hereto agrees as follows:

1 Releases

The Security Agent hereby releases any and all liens or other claims that it (or any Secured Creditor) has or may at any time have had in the IP Collateral under the Security Agreement.

2 Authorization of Filings

In connection with this Release, the Security Agent hereby authorizes the Grantor (or its agent) to record this Release with the US Patent and Trademark Office to evidence the release of the Security Agent's security interest in the IP Collateral under the Security Agreement without the signature of the Security Agent or any Secured Creditor, to the extent permitted by law.

3 Further Assurances

The Security Agent further agrees to furnish to the Grantor, at the Grantor's expense, any additional releases and/or termination statements and such other and further documents,

instruments and agreements as may reasonably be requested by such party, in order to effect and evidence more fully the releases contained herein and the matters covered hereby.

4 Severability

If any provision of this Release, or the application thereof to any party or any circumstance is held invalid or unenforceable, the remainder of this Release and the application of such provision to any other party and any other circumstances will not be affected thereby, the provisions of this Release being severable in any such instance.

5 Governing Law

This Release shall be governed by and construed in accordance with the laws of the State of New York (including, without limitation, Section 5-1401 of the General Obligations Law of the State of New York), without regard to conflict of laws principles that would require application of another law. This Release will be binding upon and inure to the benefit of each party and its successors and assigns.


