**NOTICE OF ASSIGNMENT OF TRADEMARK
SECURITY AGREEMENT (FIRST LIEN)**

This Notice of Assignment of Trademark Security Agreement (“Notice of Assignment”), dated February 24, 2012, is between Deutsche Bank Trust Company Americas, as Collateral Agent (“Assignor”) and Comerica Bank, as Collateral Agent (“Assignee”).


EnviroSolutions, Inc. (“Grantor”) and Assignor entered into that certain Grant of Security in Trademark Rights (“Trademark Security Agreement”) dated as of July 29, 2010, which was recorded in the records of the U.S. Trademark Office at Reel/Frame 4251/0818, and that certain First Lien Guarantee and Collateral Agreement (as defined in the Trademark Security Agreement)., whereby Grantor granted to Assignor a continuing security interest in all of its right, title and interest in the Trademarks (as defined therein). 


