**RELEASE OF SECURITY INTEREST IN
INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE, dated as of February 22, 2012, is made by DEUTSCHE BANK AG, NEW YORK BRANCH, in its capacity as Collateral Agent (the "Collateral Agent") pursuant to the Security Agreement, dated as of June 27, 2008 (as amended, modified, restated and/or supplemented from time to time, the "Security Agreement"). Capitalized terms used herein not otherwise defined herein shall have the meanings ascribed thereto in the Security Agreement.

W I T N E S S E T H

WHEREAS, MOBILE MINI, INC., a Delaware corporation ("Mobile Mini"), MOBILE STORAGE GROUP, INC. ("Mobile Storage Group"), a Delaware corporation, and A ROYAL WOLF PORTABLE STORAGE, INC., a California corporation ("A Royal Wolf") (collectively, the "Grantors"), and the Collateral Agent are parties to the Security Agreement;

WHEREAS, pursuant to the Security Agreement, Mobile Mini executed the Grant of Security Interest in United States Patents dated June 27, 2008 and recorded with the U.S. Patent and Trademark Office on June 27, 2008 at Reel/Frame No. 21158/0842, pursuant to which Mobile Mini granted to the Collateral Agent a security interest in (i) all of its rights, title and interest in and to the United States patents set forth in Schedule I ("Patents") together with (ii) all Proceeds and products of the Patents, and (iii) all causes of action arising prior to or after the date hereof for infringement of any of the Patents or unfair competition regarding the same (the "Patent Collateral");

WHEREAS, pursuant to the Security Agreement, the Grantors executed the Grant of Security Interest in United States Trademarks dated June 27, 2008 and recorded with the U.S. Patent and Trademark Office on June 27, 2008 at Reel/Frame Nos. 3807/0123, 3807/0142, and 3807/0148, pursuant to which the Grantors granted to the Collateral Agent a security interest in (i) all of the Grantors' right, title and interest in and to the United States trademarks, trademark registrations and trademark applications set forth in Schedule I (the "Marks"), (ii) all Proceeds and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same (the "Trademark Collateral");

WHEREAS, pursuant to the Security Agreement, Mobile Mini executed the Grant of Security Interest in United States Copyrights dated June 27, 2008 and recorded with the U.S. Copyright Office on November 4, 2008 at V3571 D017, pursuant to which Mobile Mini granted to the Collateral Agent a security interest in and lien upon its copyrights and copyright registrations and applications as set forth in Schedule I (the "Copyright Collateral");

WHEREAS, the Grantors have requested that the Collateral Agent release its security interest and lien on all of its right, title and interest in and to the Patent Collateral, Trademark Collateral, and Copyright Collateral.

NOW, THEREFORE, the Collateral Agent hereby RELEASES, without recourse its security interest and lien on all of its right, title and interest in and to the Patent Collateral, Trademark Collateral, and Copyright Collateral, including the intellectual property set forth in Schedule I, attached hereto and incorporated herein by reference.

The Collateral Agent agrees to provide the Grantors with any information and additional authorization reasonably necessary to effect the release of the Collateral Agent's security interest in the Patent Collateral, Trademark Collateral, and Copyright Collateral.
