

**TERMINATION AND RELEASE  
OF TRADEMARK COLLATERAL  
SECURITY AND PLEDGE AGREEMENT**

This TERMINATION AND RELEASE OF TRADEMARK COLLATERAL SECURITY AND PLEDGE AGREEMENT (the "Release") is dated as of March 26, 2012 and executed by Citizens Bank of Pennsylvania, a Pennsylvania corporation, having an office at 525 William Penn Place, Pittsburgh, Pennsylvania ("Lender").

WHEREAS, pursuant to the terms of that certain Trademark Collateral Security and Pledge Agreement (the "Trademark Agreement") dated July 20, 2010 by and between the Lender and The Blonder Company, a Delaware corporation having its principal place of business at 3950 Prospect Avenue, Cleveland, Ohio (the "Company") and recorded with the U.S. Patent and Trademark Office at Trademark Reel 004271 and Frame 0755-0774, the Company granted to the Lender a security interest in and lien on, and collaterally assigned to the Lender, the trademarks, trademark registrations and associated goodwill identified on Schedule A attached hereto (such trademarks referred to herein as the "Named Trademarks"); and

WHEREAS, the Lender has agreed to terminate and release its security interest and all of its right, title and interest in each of the Named Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby terminates and releases its security interest in and first priority lien on the Named Trademarks, and the Lender hereby assigns and transfers to the Company, without recourse, all of the Lender's right, title and interest in and to each of the Named Trademarks and the related trademark registrations and goodwill, effective as of May 23, 2011.

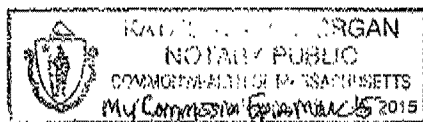
