TRADEMARK ASSIGNMENT

ASSIGNMENT effective the 2nd day of April, 2012, by and between FEDERAL-MOGUL WORLD WIDE, INC., a Michigan corporation having its principal place of business at 26555 Northwestern Highway, Southfield, Michigan 48034, (hereinafter "Assignor"), and FEDERAL-MOGUL CORPORATION, a Delaware corporation having its principal place of business at 26555 Northwestern Highway, Southfield, Michigan 48033, (hereinafter "Assignee").

WHEREAS, ASSIGNOR has adopted and is using, or is using through a related company, the trademark FEDERAL MOGUL (the "Mark"), and is the owner of the United States Trademark Registration No. 1,658,813;

ASSIGNOR further assigns to ASSIGNEE all rights to sue for and receive all damages occurring from any past infringing uses of the Mark.

ASSIGNOR warrants that it has good and valid title to the Mark, including the registration therefor.

ASSIGNOR agrees that upon request by ASSIGNEE, ASSIGNOR shall execute all papers, make all rightful oaths, testify on behalf of ASSIGNEE, and do other lawful acts necessary to carry to the intent of this Assignment at ASSIGNEE's expense and request, as well as provide such documents, material, information, or assistance as ASSIGNEE may consider necessary.

This ASSIGNMENT shall be binding on the parties, their successors and / or assigns, and all others acting by, through, with, or under their direction, and all those in privity therewith.
