RELEASE OF SECOND LIEN SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECOND LIEN SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of April 5, 2012, by Credit Suisse AG, Cayman Islands Branch, as Administrative Agent (as defined below) for the Lenders, in favor of each Grantor listed on Schedule I hereto (the "Grantors"). Terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement referred to below.

A. Reference is made to the Second-Lien Credit Agreement dated as of March 2, 2007 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), among Infor Global Solutions Intermediate Holdings Limited, a company organized under the laws of the Cayman Islands ("Topco"), Infor Lux Finance Company, a société à responsabilité limitée having its registered office at 8-10 rue Mathias Hardt, L-1717 Luxembourg, registered with the Luxembourg register of trade and companies under section B number 118.070 and having a share capital of \$234,500 ("Holdings"), Infor Global Solutions European Finance S.à R.L., a société à responsabilité limitée having its registered office at 8-10 rue Mathias Hardt, L-1717 Luxembourg, registered with the Luxembourg register of trade and companies under section B number 107.138 and having a share capital of \$20,000 (the "Lux Borrower"), Infor Enterprise Solutions Holdings, Inc. (f/k/a Magellan Holdings, Inc.), a Georgia corporation (together with the Lux Borrower, the "Borrowers"), the Lenders party thereto from time to time, Credit Suisse, Cayman Islands Branch, as Administrative Agent (the "Administrative Agent") and the other agents thereunder.

B. Reference is made to the Second-Lien Guarantee and Collateral Agreement dated as of March 2, 2007 (as amended, supplemented or otherwise modified from time to time, the "Collateral Agreement"), among Infor Lux Bond Company, a société à responsabilité limitée having its registered office at 8-10 rue Mathias Hardt, L-1717 Luxembourg, registered with the Luxembourg register of trade and companies under section B number 113718 and having a share capital of EUR 12,500.-, Infor Isa Holdings, a société à responsabilité limitée having its registered office at 8-10 rue Mathias Hardt, L-1717 Luxembourg, in the process of being registered with the register of trade and companies in Luxembourg and having a share capital of \$18,000, Holdings, the Borrowers, the Subsidiaries of Topco party thereto and Credit Suisse, Cayman Islands Branch, as Administrative Agent, pursuant to which, among other things, the Grantors granted a security interest to the Administrative Agent, for the benefit of certain secured parties named therein, in, among other things, the issued trademarks and pending trademark applications of the Grantors and certain of its subsidiaries set forth on Annex I hereto (the "Trademarks"), pursuant to:

(i) Short Form Trademark Security Agreement dated as of March 31, 2006, among the Subsidiary Parties listed on Schedule I thereto and Credit Suisse AG, Cayman Islands Branch, as Second Lien Collateral Agent, recorded with the United States Patent and Trademark Office (the "PTO") at Reel 003301 Frame 0144 on May 2, 2006,

(ii) Short Form Trademark Security Agreement dated as of March 2, 2007, among the Subsidiary Parties listed on Schedule I thereto and Credit Suisse AG, Cayman Islands Branch, as Administrative Agent, recorded with the PTO at Reel 003538 Frame 0180 on May 8, 2007,

(iii) Short Form Trademark Security Agreement dated as of June 1, 2007, among the Subsidiary Parties listed on Schedule I thereto and Credit Suisse AG, Cayman Islands Branch, as Administrative Agent, recorded with the PTO at Reel 003565 Frame 0037 on June 20, 2007,

(iv) Short Form Trademark Security Agreement dated as of November 15, 2007, among the Subsidiary Parties listed on Schedule I thereto and Credit Suisse AG, Cayman Islands Branch, as Administrative Agent, recorded with the PTO at Reel 003677 Frame 0119 on December 13, 2007 and

(v) Short Form Trademark Security Agreement dated as of June 2, 2010, among the Subsidiary Parties listed on Schedule I thereto and Credit Suisse AG, Cayman Islands Branch, as Administrative Agent, recorded with the PTO at Reel 004222 Frame 0568 on June 10, 2010

C. In connection with the termination of the Collateral Agreement, the Borrowers have informed the Administrative Agent of their desire to obtain the release of all right, title and interest of the Administrative Agent, the Lenders and each other grantee or beneficiary in and to the Trademarks granted under the Collateral Agreement.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, all the Administrative Agent's right, title and interest (including, without limitation, security interests) in and to the Trademarks pursuant to the Collateral Agreement shall automatically terminate as provided in the Collateral Agreement, including, without limitation, the Trademarks set forth on Annex I attached hereto, the debt secured thereby having been paid and satisfied in full and any right, title or interest of the Administrative Agent in such Trademarks shall hereby cease and become void.

The Administrative Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby at the cost and request of the Borrowers. This Release shall be construed in accordance with and governed by the laws of the State of New York.


