## TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of April 30, 2012 by MADISON CAPITAL FUNDING LLC, as Agent for the Lenders (the "Bank").

WITNESSETH:

WHEREAS, Bank and Kan-Di-Ki, LLC, a California limited liability company ("Grantor") were parties to that certain Trademark Security Agreement dated as of December 1, 2010 (the "Agreement") and pursuant to which Grantor granted a security interest to Bank in its trademarks and trademark licenses (the "Secured Trademarks") including the Secured Trademarks set forth on Schedule 1 hereto; and

2. Bank hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Bank, all of Bank's right, title and interest (if any) in and to the Secured Trademarks.
