## **FIRST LIEN INTELLECTUAL PROPERTY SECURITY RELEASE AGREEMENT**

This FIRST LIEN INTELLECTUAL PROPERTY SECURITY RELEASE AGREEMENT (the "***First Lien IP Security Release***") is made as of May 9, 2012, by Bank National Association, as collateral trustee (the "***Trustee***"), for each of the Secured Parties (as defined in the Loan Agreement referred to below), in favor of the granting parties identified below. All capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed to those terms in the Loan Agreement and the First Lien IP Security Agreement (as defined below).

WHEREAS, SOLO CUP OPERATING CORPORATION, a Delaware corporation ("SCOC"), SOLO CUP COMPANY, a Delaware corporation (together with SCOC, the "Issuers" and, each, an "Issuer"), the subsidiaries of the Issuers from time to time party thereto, the Trustee (as defined therein), the other Secured Debt Representatives from time to time party thereto and the Collateral Trustee have entered into a Collateral Trust Agreement dated as of July 2, 2009 (as amended, amended and restated, waived, renewed, replaced, restructured, supplemented or otherwise modified from time to time, the "Collateral Trust Agreement"). Terms defined in the Collateral Trust Agreement and not otherwise defined herein are used herein as defined in the Collateral Trust Agreement.

WHEREAS, as a condition precedent to the Secured Parties making their respective extensions of credit and other accommodations as set forth in the Priority Lien Documents, each Grantor has executed and delivered that certain Security Agreement dated as of July 2, 2009 by and among the Grantors and the Collateral Trustee (as amended, amended and restated, waived, renewed, replaced, restructured, supplemented or otherwise modified from time to time, the "Security Agreement").

WHEREAS, under the terms of the Security Agreement, the Grantors have granted to the Collateral Trustee, for the ratable benefit of the Secured Parties, a security interest in, among other property, certain intellectual property of the Grantors, and have agreed as a condition thereof to execute this IP Security Agreement for recording with the U.S. Patent and Trademark Office, the United States Copyright Office and other governmental authorities

WHEREAS, the First Lien IP Security Agreement was recorded with the Patent Division of the United States Patent and Trademark Office on July 2, 2009, at Reel 022910 and Frame 0054; with the Trademark Division of the United States Patent and Trademark Office on July 2, 2009, at Reel 004015 and Frame 0591; and with the United States Copyright Office;

WHEREAS, in accordance with the terms of the Payoff Letter (the "***Payoff Letter***") dated May 4, 2012 and given by the Trustee, the obligations secured by the Collateral have been repaid or otherwise satisfied to the extent set forth in such Payoff Letter; and

WHEREAS, the Trustee therefore desires to release its security interest in and to the Grantors' right, title and interest in and to the Collateral identified in Schedule 1A, 1B and 1C, and 2A and 2B attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent hereby agrees as follows:

SECTION 1. Release of Security Interest under First Lien IP Security Agreement. The Agent does hereby release and convey to Solo Cup Operating Corporation, Solo Cup Company, SF Holdings Group, Inc., Solo Manufacturing LLC, P.R. Solo Cup, Inc., Lily-Canada Holding Corporation and Solo Cup Owings Mills Holdings, without recourse, representation or warranty of any kind, all of the Trustee's right, title and interest in and to their right, title and interest in and to the Collateral identified in Schedule 1A, 1B and 1C attached hereto.

SECTION 2. Release of Security Interest under IP Security Agreement Supplement. The Agent does hereby release and convey to Solo Cup Operating Corporation, without recourse, representation or warranty of any kind, all of the Trustee's right, title and interest in and to Solo Cup Operating Corporation's right, title and interest in and to the Collateral identified in Schedule 2A and 2B attached hereto.

SECTION 3. Recordation. The Agent hereby authorizes and requests that the Register of Copyrights, the Commissioner for Patents and the Commissioner for Trademarks and any other applicable government officer record this First Lien IP Security Release.

SECTION 4. Execution in Counterparts. This First Lien IP Security Release may be executed and delivered (including by facsimile transmission) in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

SECTION 5. Governing Law. This First Lien IP Security Release shall be governed by, and construed in accordance with, the laws of the State of New York.
