**RELEASE OF TRADEMARK COLLATERAL ASSIGNMENT

WHEREAS, Borrower and Lender entered into a certain Factoring Agreement, dated April 11, 1997, as amended (the "Agreement"); and



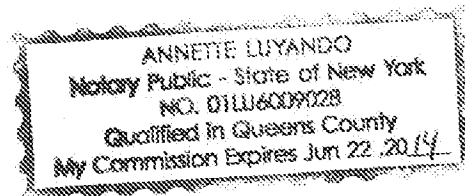
