TRADEMARK ASSIGNMENT

ASSIGNOR agrees that upon request by ASSIGNEE, ASSIGNOR shall execute all papers, make all rightful oaths, testify on behalf of ASSIGNEE, and do other lawful acts necessary to carry to the intent of this Assignment at ASSIGNEE's expense and request, as well

as provide such documents, material, information, or assistance as ASSIGNEE may consider necessary.

This ASSIGNMENT shall be binding on the parties, their successors and / or assigns, and all others acting by, through, with, or under their direction, and all those in privity therewith.
