TECHNICAL RELEASE OF INCORRECT RECORDATION OF  
TRADEMARK SECURITY INTEREST, dated as of June 20, 2012 (this  
"Release"), by Wells Fargo Capital Finance, Inc. (as successor in interest to  
Foothill Capital Corporation) in favor of Springs Global US, Inc.

Reference is made to a Trademark Security Agreement dated as of October 27,  
2000 ("Security Agreement") made by BC Holdings, LLC, BC Holding I Corporation, BC  
Holding II Corporation, BC Holding III Corporation, Billing Concepts, Inc., Enhanced Services  
Billing, Inc., Aptis, Inc. and Operator Service Company (collectively, "Grantors") in favor of  
Foothill Capital Corporation (the "Secured Party").

WHEREAS, pursuant to the Security Agreement, Grantors on Schedule A  
attached to the Security Agreement purported to grant to the Secured Party a security interest in  
the trademark listed on Schedule I hereto and registered with the United States Patent and  
Trademark Office under Reg. No. 2,328,437 (such trademark and all registrations, recordings  
and applications related thereto, collectively, the "Trademark"), which Trademark in fact was not  
owned by Grantors and was listed erroneously on such Schedule A as a result of a typographical  
error, and which Trademark is owned by an unrelated third party, Springs Global US, Inc., a  
Delaware corporation with offices at 205 N. White Street ("Owner");

WHEREAS, the Security Agreement and Schedule A were filed with the United  
States Patent and Trademark Office on December 12, 2000 and recorded at Reel 002192, Frame  
0866, and Wells Fargo Capital Finance, Inc., as successor in interest to the Secured Party, wishes  
to cancel the incorrect recordation of a security interest in the Trademark;

NOW THEREFORE, for good and valuable consideration, the receipt and  
sufficiency of which are hereby acknowledged, Wells Fargo Capital Finance, Inc., as successor  
in interest to the Secured Party, does hereby release, terminate, cancel, relinquish, discharge and  
reassign to Owner all right, title and interest, if any, it has in and to the Trademark, including  
without limitation any and all security interests in the Trademark and any and all other rights  
with respect to or arising out of the Trademark purportedly granted to the Secured Party pursuant  
to the Security Agreement, and does hereby agree that the filing of the Security Agreement in the  
United States Patent and Trademark Office as aforesaid may be removed of record with respect  
to the Trademark.
