RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (“Release”) is made effective as of June 26, 2012 by JPMorgan Chase Bank, N.A. (the “Secured Party”) to informedRx, Inc., as successor in interest by merger to National Medical Health Card Systems, Inc. (the “Grantor”), as follows:

WHEREAS, on January 28, 2005 (the “Original Closing Date”), the Grantor and the Secured Party entered into a Trademark Security Agreement (the “Security Agreement”);

WHEREAS, pursuant to the Security Agreement, the Grantor granted to the Secured Party on behalf of the Lenders, among other collateral, a continuing security interest in, and lien on, all of the Grantor’s right, title and interest, including goodwill, in, to and under the trademarks listed on the attached Schedule A and recordings and applications therefor (the “Marks”);

NOW THEREFORE, for valuable consideration, the Secured Party hereby releases, without any recourse, statement, representation and warranty, promise or undertaking whatsoever, and at the Grantor’s sole cost and expense, all right, title and interest in and to the Marks, including: (i) its security interest in and lien upon the Marks; (ii) all goodwill of the business connected with the use of, and symbolized by, each Mark; and (iii) all products and proceeds of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future (a) infringement or dilution of any Mark or (b) injury to the goodwill associated with any Mark.
