

**TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of July 2, 2012, and made by JPMorgan Chase Bank, N.A., having an office at 2200 Ross Avenue, 3<sup>rd</sup> Floor, TX1-2903, Dallas, Texas 75201 ("JPMorgan") to Pei Wei Asian Diner, Inc. and P.F. Chang's China Bistro, Inc. (the "Grantors").

WHEREAS, certain security interests (the "Interests") were granted by the Grantors to JPMorgan in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Interests were recorded in the Assignment Division of the United States Patent and Trademark Office on August 9, 2006, at Reel 3366 and Frame 0294;

WHEREAS, JPMorgan now desires to terminate and release the Interests; and
